

16. PROCEDURES FOR APPLICATION AND ACCEPTANCE

16.1 Opening and Closing of Application

Applications will be accepted from 10.00 a.m. on 30 June 2005 and will remain open until 5.00 p.m. on 18 July 2005. Our Directors and/or the Offerors and the Underwriter may mutually decide, at their discretion, to extend the closing date of the application to any later date or dates. We will not accept late applications.

If the closing date for the application is extended, we will announce the extension in a widely circulated English and Bahasa Malaysia newspaper in Malaysia.

16.2 Methods of Application

You can apply for the Public Issue Shares using either of the following ways:

- (i) Application Forms; or
- (ii) Electronic Share Applications; or
- (iii) Internet Share Applications.

16.3 Procedures for Application

16.3.1 Application by Bumiputera investors approved by the MITI

Applications for the 67,500,000 Offer Shares by the Bumiputera investors approved by the MITI must be made on the **White** Application Forms provided only and **NOT** by way of other Application Forms or by way of Electronic Share Application or Internet Share Application.

16.3.2 Application by our Directors, eligible employees and business associates

Applications for the 7,515,000 Public Issue Shares reserved for our Directors, eligible employees and business associates must be made on the **Pink** Application Forms provided only and **NOT** by way of other Application Forms or by way of Electronic Share Application or Internet Share Application.

16.3.3 Application by Malaysian public

Applications for the 15,000,000 Public Issue Shares made available for application by the Malaysian citizens, companies, co-operatives, societies and institutions by way of balloting, of which at least 30% is to be set aside for Bumiputera individuals, companies, co-operatives, societies and institutions must be made on the **White** Application Forms provided or by way of Electronic Share Application or Internet Share Application.

However, a corporation or institution cannot apply for the Public Issue Shares by way of Electronic Share Application or Internet Share Application.

A person who submits multiple applications in his own name or by using the name of others, with or without their consents, commits an offence under Section 87A of the Securities Industry Act, 1983 ("SIA") and if convicted, may be punished with a minimum fine of RM1,000,000 and a jail term of up to ten (10) years under Section 88B of the SIA. Only one Application Form from each applicant will be considered and applications must be for 100 ordinary shares or multiples thereof. Multiple applications will not be accepted, and applications appearing to be, or suspected of being multiple applications may be rejected at the discretion of the Directors of NHR. The amount payable in full on application is RM0.33 per share. Persons submitting applications by way of Application Forms may not submit applications by way of Electronic Share Applications or Internet Share Applications and vice versa.

16. PROCEDURES FOR APPLICATION AND ACCEPTANCE *(Cont'd)*

Persons submitting applications by way of Application Forms or Electronic Share Applications or Internet Share Applications **must have a CDS account**.

Your applications shall be made in relation with and subject to the terms of this Prospectus and our Memorandum and Articles of Association.

IF YOU ARE AN INDIVIDUAL AND YOU ARE NOT A MEMBER OF THE ARMED FORCES OR POLICE, YOUR NAME, NATIONAL REGISTRATION IDENTITY CARD ("NRIC") NUMBER MUST BE EXACTLY THE SAME AS STATED IN:

- (i) (a) YOUR NRIC;
- (b) ANY VALID TEMPORARY IDENTITY DOCUMENTS ISSUED BY THE NATIONAL REGISTRATION DEPARTMENT FROM TIME TO TIME; OR
- (c) YOUR "RESIT PENGENALAN SEMENTERA (JPN 1/9)" ISSUED PURSUANT TO PERATURAN 5(5), PERATURAN-PERATURAN PENDAFTARAN NEGARA 1990; AND
- (ii) THE RECORDS OF THE DEPOSITORY, IF ANY.

IF YOU ARE A MEMBER OF THE ARMED FORCES OR POLICE, YOUR NAME AND YOUR ARMED FORCES OR POLICE PERSONNEL NUMBER, AS THE CASE MAY BE MUST BE EXACTLY THE SAME AS THAT STATED IN YOUR AUTHORITY CARD.

FOR CORPORATE/INSTITUTIONAL APPLICANT, THE NAME AND THE CERTIFICATE OF INCORPORATION NUMBER MUST BE EXACTLY THE SAME AS THAT STATED IN THE CERTIFICATE OF INCORPORATION.

We will not issue any acknowledgement of the receipt of your Application Forms or application monies.

16.4 Application using Application Form

16.4.1 Types of Application Form

We enclose the following Application Forms with this Prospectus which are deemed to form part hereof:

- (i) **Pink** Application Form for application by our Directors, eligible employees and business associates;
- (ii) **White** Application Form for application by Bumiputera investors approved by the MITI in respect of Offer Shares and for application by Malaysian citizens, companies, societies, co-operatives and institutions of which at least 30% is to be set aside strictly for Bumiputera individuals, companies, societies, co-operatives and institutions.

White Application Forms together with copies of this Prospectus may be obtained, subject to availability, from Hwang-DBS, participating organisations of Bursa Securities, members of the Association of Banks in Malaysia, members of the Association of Merchant Banks in Malaysia and MHH.

16. PROCEDURES FOR APPLICATION AND ACCEPTANCE *(Cont'd)*

16.4.2 Terms and conditions for application by Malaysian Public using Application Form

Your application by way of Application Form shall be made on, and subject to, the terms and conditions appearing below:

- (i) You are an individual Malaysian citizen residing in Malaysia, with a CDS account and a Malaysian address.
- (ii) You are a corporation / institution incorporated in Malaysia, with a CDS account and are subject to the following:
 - (a) If you have a share capital, more than half of your issued share capital (excluding preference share capital) is held by Malaysian citizens; and
 - (b) There is a majority of Malaysian citizens on your board of Directors/trustee.
- (iii) You are a superannuation, provident or pension fund established or operating in Malaysia and have a CDS account.
- (iv) We will not accept applications from trustees, person under 18 years of age, sole proprietorships, partnerships or other incorporated bodies or associations, other than corporations/institutions referred to in Sections 16.4.2(ii) and (iii) above or the trustees thereof.
- (v) You can apply for the Public Issue Shares using relevant Application Forms issued together with this Prospectus and you must complete the Application Form in accordance with the Notes and Instructions printed on the reverse side of the Application Form and this Prospectus. In accordance with Section 41(2) of the Securities Commission Act, 1993, the Application Form together with the Notes and Instructions printed therein is accompanied by this Prospectus. We will not accept your applications if they do not conform **STRICTLY** to the terms of this Prospectus or the Notes and Instructions printed on the Application Form therein or which are illegible.
- (vi) **EACH COMPLETED APPLICATION FORM MUST BE ACCOMPANIED BY REMITTANCE IN RINGGIT MALAYSIA FOR THE FULL AMOUNT PAYABLE BY EITHER:**

- (vii) YOU MUST STATE YOUR CDS ACCOUNT NUMBER IN THE SPACE PROVIDED IN THE APPLICATION FORM AND YOU SHALL BE DEEMED TO HAVE AUTHORISED DEPOSITORY TO DISCLOSE INFORMATION PERTAINING TO THE CDS ACCOUNT TO MIH/COMPANY.
- (viii) YOUR NAME AND ADDRESS MUST BE WRITTEN ON THE REVERSE SIDE OF THE BANKER'S DRAFT, CASHIER'S ORDER, ATM STATEMENT, MONEY ORDER, CHEQUES ISSUED BY PARTICIPATING LICENSED FINANCE COMPANIES OR GGO FROM BANK SIMPANAN NASIONAL MALAYSIA BERHAD.
- (ix) Our Directors reserve the right to require you, if you are successful in your application, to appear in person at the registered office of MIH within fourteen (14) days of the date of the notice issued to you to ascertain your application is genuine and valid. Our Directors shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by you for the purpose of complying with this provision.

16. PROCEDURES FOR APPLICATION AND ACCEPTANCE *(Cont'd)*

- (x) MIH under the authority of our Directors reserves the right to reject your applications which do not conform to these instructions or which are illegible or which are accompanied by remittances improperly drawn.
- (xi) MIH under the authority of our Directors reserves the right not to accept your application in part only without assigning any reason therefor. Due consideration will be given to the desirability of allotting or allocating our Shares to a reasonable number of applicants with a view to establishing an adequate market for our Shares.
- (xii) If your application is not accepted or accepted in part only, we will return and despatch the full amount or the balance of the application monies, as the case may be, without interest, to you within ten (10) Market Days from the date of the final ballot of the applications lists by ordinary post (if your application is fully unaccepted) or registered post (if your application is partially accepted) at your address last maintained with the Depository. If your application is not accepted because you did not provide a CDS account number, your application monies will be sent to your address stated in the National Registration Identity Card or "Resit Pengenalan Sementara (JPN 1/9)" or any valid temporary identity document as issued by the National Registration Department from time to time.
- (xiii) You shall ensure that your personal particulars stated in the Application Form are identical with the records maintained by the Depository. You must inform the Depository promptly of any change in address failing which the notification letter of successful allocation will be sent to your registered or correspondence address last maintained with the Depository.

- (xvi) You are not a Director or employee of MIH or their immediate families as they are strictly prohibited from applying for the Public Issue Shares.
- (xvii) **YOU MAY DIRECT ALL YOUR ENQUIRIES IN RESPECT OF THE WHITE APPLICATION FORM TO MIH.**

16.5 Application via Electronic Share Application

16.5.1 Steps for Electronic Share Application through a Participating Financial Institution's ATM

- (i) You must have an account with a Participating Financial Institution (as detailed in Section 16.5.2(xv) below) and an ATM card issued by that Participating Financial Institution to access the said account.
- (ii) You must have a CDS account.
- (iii) Choose the Electronic Share Application option at the ATM of the Participating Financial Institution. Mandatory statements required in the application are set out in Section 16.5.2 below under the Terms and Conditions for Electronic Share Application. Enter at least the following information through the ATM where the instructions on the ATM screen require you to do so:
 - Personal Identification Number (PIN);
 - MIH Share Issue Account No. 374;
 - CDS Account Number;
 - Number of Public Issue Shares, applied for and/or the Ringgit Malaysia amount to be debited from the account; and
 - Confirmation of several mandatory statements.

16.5.2 Terms and conditions of Electronic Share Application

The procedures for Electronic Share Application at ATMs of the Participating Financial Institutions are set out on the ATM screens of the relevant Participating Financial Institutions (the "Steps"). For illustration purposes, the procedures for Electronic Share Application at ATMs are set out in "Steps for Electronic Share Application through a Participating Financial Institution's ATM" in Section 16.5.1 above. The Steps set out the actions that you must take at the ATM to complete an Electronic Share Application. Please read carefully the terms of this Prospectus, the Steps and the terms and conditions for Electronic Share Application set out below before making an Electronic Share Application. Any reference to "applicant" in the terms and conditions for Electronic Share Application and the Steps shall mean the applicant who applies for shares through an ATM of any of the Participating Financial Institutions.

Only an individual with a CDS account is eligible to utilise the facility.

You must have an existing bank account with, and be an ATM cardholder of, one of the Participating Financial Institutions before you can make an Electronic Share Application at an ATM of that Participating Financial Institutions. An ATM card issued by one of the Participating Financial Institutions cannot be used to apply for shares at an ATM belonging to other Participating Financial Institutions. Upon completion of your Electronic Share Application transaction, you will receive a computer-generated transaction slip ("Transaction Record"), confirming the details of your Electronic Share Application. The Transaction Record is only a record of the completed transaction at the ATM and not a record of the receipt of the Electronic Share Application or any data relating to such an Electronic Share Application by our Company or MIH. The Transaction Record is for your retention and should not be submitted with any Application Form.

16. PROCEDURES FOR APPLICATION AND ACCEPTANCE *(Cont'd)*

Upon the closing of the offer for the application for the Public Issue Shares, on 18 July 2005 at 5.00 p.m. ("Closing Date and Time"), the Participating Financial Institution shall submit a magnetic tape containing its respective customers' applications for the Public Issue Shares to MIH as soon as practicable but not later than 12.00 p.m. of the second business day after the Closing Date and Time.

You will be allowed to make an Electronic Share Application for shares via an ATM that accepts the ATM cards of the Participating Financial Institution with which you have an account and its branches, subject to you making only one (1) application. You can apply for our Shares at an ATM of the Participating Financial Institution which is situated in another country or place outside of Malaysia, subject to you making only one (1) application.

YOU MUST ENSURE THAT YOU USE YOUR OWN CDS ACCOUNT NUMBER WHEN MAKING AN ELECTRONIC SHARE APPLICATION. IF YOU HAVE A JOINT ACCOUNT WITH ANY PARTICIPATING FINANCIAL INSTITUTION, YOU MUST ENSURE THAT YOU ENTER YOUR OWN CDS ACCOUNT NUMBER WHEN USING AN ATM CARD ISSUED TO YOU IN YOUR OWN NAME. Your Electronic Share Application shall be made on, and subject to, the terms and conditions contained herein as well as the terms and conditions appearing below:

- (i) Your Electronic Share Application shall be made in connection with and subject to the terms of this Prospectus and our Memorandum and Articles of Association.
- (ii) You are required to confirm and undertake that the following mandatory statements are true and correct by depressing pre-designated keys or buttons on the ATM keyboard:
 - You have attained 18 years of age as at the closing date of the share application;
 - You are a Malaysian citizen residing in Malaysia;
 - You have read the Prospectus and have understood and agreed with the terms and conditions of this application;
 - This is the only application that you are submitting; and
 - You give consent to the Participating Financial Institution and the Depository to disclose information pertaining to yourself and your account with the Participating Financial Institution and the Depository to MIH and other relevant authorities.

Your application will not be successfully completed and cannot be recorded as a completed transaction at the ATM unless you have completed all the steps and followed instructions set out on the ATM screen. By doing so, you shall be treated as signifying your confirmation of each of the above statements as well as giving consent in accordance with the relevant laws of Malaysia including Section 97 of the Banking and Financial Institutions Act, 1989 and Section 45 of the Securities Industry (Central Depositories) Act, 1991 to the disclosure by the relevant Participating Financial Institution or the Depository, as the case may be, of any of your particulars to MIH, or any relevant regulatory bodies.

16. PROCEDURES FOR APPLICATION AND ACCEPTANCE *(Cont'd)*

- (iii) YOU ARE NOT APPLYING FOR SHARES AS A NOMINEE OF ANY OTHER PERSON AND THE ELECTRONIC SHARE APPLICATION IS MADE IN YOUR OWN NAME AS BENEFICIAL OWNER. YOU SHALL ONLY MAKE ONE ELECTRONIC SHARE APPLICATION AND SHALL NOT MAKE ANY OTHER APPLICATION FOR THE PUBLIC ISSUE SHARES, WHETHER AT THE ATMS OF ANY PARTICIPATING FINANCIAL INSTITUTION OR ON THE PRESCRIBED APPLICATION FORMS.
- (iv) You must have sufficient funds in your account with the relevant Participating Financial Institution at the time you make the Electronic Share Application, failing which your Electronic Share Application will not be completed. We will reject any Electronic Share Application which does not strictly conform to the instructions set out on the screens of the ATM.
- (v) You agree and undertake to subscribe for or purchase and to accept the number of shares applied for as stated on the Transaction Record or any lesser number of shares that may be allotted or allocated to you in respect of your Electronic Share Application. If we decide to allot or allocate any lesser number of such shares or not to allot or allocate any shares to you, you agree to accept any such decision as final. If your Electronic Share Application is successful, your confirmation (by your action of pressing the designated key or button on the ATM) of the number of shares applied for shall signify, and shall be treated as, your acceptance of the number of shares that may be allotted or allocated to you and to be bound by our Memorandum and Articles of Association.
- (vi) MIH under the authority of our Directors reserves the right to reject any Electronic Share Application or accept any Electronic Share Application in part only without assigning any reason therefor. Due consideration will be given to the desirability of allotting or allocating our Shares to a reasonable number of applicants with a view to establishing an adequate market for our Shares.
- (vii) MIH shall inform the Participating Financial Institutions of the non-successful or partially successful applications within two (2) Market Days after the balloting date. If your Electronic Share Application is not successful, the relevant Participating Financial Institution will credit the full amount of the application monies without interest into your account with that Participating Financial Institution within two (2) Market Days after the receipt of confirmation from MIH. You may check your accounts on the fifth (5th) market day from the balloting day.

If your Electronic Share Application is accepted in part only, the relevant Participating Financial Institution will credit the balance of the application monies without interest into your account with the Participating Financial Institution within two (2) Market Days after the receipt of confirmation from MIH. A number of applications will, however, be held in reserve to replace any successfully balloted applications which are subsequently rejected. For such applications which are subsequently rejected, the application monies without interest will be refunded to you by MIH by way of cheques issued by MIH. The cheques will be issued to you not later than ten (10) Market Days from the day of the final ballot of the application list. If you encounter any problems in your applications, you may refer to the Participating Financial Institutions.

- (viii) You request and authorise us to:
 - (a) credit our Shares allotted or allocated to you into your CDS account; and
 - (b) issue share certificate(s) representing such Shares allotted or allocated in the name of Bursa Malaysia Depository Nominees Sdn Bhd and sends the same to the Depository.

- (ix) You acknowledge that your Electronic Share Application is subject to the risks of electrical, electronic, technical and computer-related faults and breakdowns, fires and other events beyond the control of our Company, MIH or the Participating Financial Institution and irrevocably agree that if:
 - (a) our Company or MIH does not receive the your Electronic Share Application; or
 - (b) data relating to the your Electronic Share Application is wholly or partially lost, corrupted or not otherwise accessible, or not transmitted or communicated to our Company or MIH,

you shall be deemed not to have made an Electronic Share Application and you shall not claim whatsoever against our Company, MIH or the Participating Financial Institutions for the shares applied for or for any compensation, loss or damage.
- (x) All your particulars in the records of the relevant Participating Financial Institution at the time you make your Electronic Share Application shall be deemed to be true and correct and our Company, MIH and the relevant Participating Financial Institution shall be entitled to rely on the accuracy thereof.
- (xi) You shall ensure that your personal particulars as recorded by both the Depository and relevant Participating Financial Institution are correct and identical. Otherwise, your Electronic Share Application is liable to be rejected. You must inform the Depository promptly of any change in address failing which the notification letter of successful allotment or allocation will be sent to your registered or correspondence address last maintained with the Depository.
- (xii) By making and completing an Electronic Share Application, you agree that:
 - (a) in consideration of our Company agreeing to allow and accept the making of any application for shares via the Electronic Share Application facility established by the Participating Financial Institutions at their respective ATMs, your Electronic Share Application is irrevocable;
 - (b) our Company, the Participating Financial Institutions, the Depository and MIH shall not be liable for any delays, failures or inaccuracies in the processing of data relating to your Electronic Share Application due to a breakdown or failure of transmission or communication facilities or to any cause beyond our control;
 - (c) notwithstanding the receipt of any payment by or on behalf of our Company, the acceptance of the offer made by you to subscribe for and purchase the shares for which your Electronic Share Application has been successfully completed shall be constituted by the issue of notices of successful allotment for prescribed securities, in respect of the said shares;
 - (d) you irrevocably authorise the Depository to complete and sign on your behalf as transferee or renounee any instrument of transfer and/or other documents required for the issue or transfer of the shares allotted or allocated to you; and

- (e) our Company agrees that, in relation to any legal action or proceedings arising out of or in connection with the contract between the parties and/or the Electronic Share Application Scheme and/or any terms herein, all rights, obligations and liabilities shall be construed and determined in accordance with the laws of Malaysia and with all directives, rules, regulations and notices from regulatory bodies and that our Company irrevocably submits to the jurisdiction of the Courts of Malaysia.
- (xiii) Our Directors reserve the right to require you, if you are successful in your application, to appear in person at the registered office of MIH within fourteen (14) days of the date of the notice issued to you to ascertain your application is genuine and valid.  - MAYBAN FINANCE BERHAD; OR
 - OCBC BANK (MALAYSIA) BERHAD; OR
 - STANDARD CHARTERED BANK MALAYSIA BERHAD (at selected branches only).
- (xvi) A surcharge of RM2.50 per Electronic Share Application will be charged by the respective Participating Financial Institution.

16.6 Application via Internet Share Application

You are only eligible to utilise Internet Share Application facility if you are an individual with a CDS account.

Please read carefully and follow the terms of this Prospectus, the procedures, terms and conditions for Internet Share Application and the procedures set out on the Internet financial services website of the Internet Participating Financial Institution before making an Internet Share Application.

16.6.1 Steps for Internet Share Application through an Internet Participating Financial Institution

Due consideration will be given to the desirability of distributing the Public Issue Shares, to a reasonable number of applicants with a view to broadening the shareholding base and establishing an adequate market in the shares of our Company. Pursuant to the Listing Requirements, at least 25% of the total number of shares of our Company for which listing is sought must be held by a minimum number of 1,000 public shareholders holding not less than 100 Shares each upon completion of the IPO and at the point of listing. In the event that the above requirement is not met pursuant to the Public Issue, our Company may not be allowed to proceed with the listing. In the event thereof, monies paid in respect of all applications will be returned without interest. Applicants will be selected in a fair and equitable manner to be determined by our Directors.

In the event of an under-subscription by Malaysian public, such shares will be made available for subscription by the underwriter.

Directors and employees of MIH and their immediate families are strictly prohibited from applying for the Public Issue Shares.

IF YOUR APPLICATION IS NOT ACCEPTED OR ACCEPTED IN PART ONLY, WE WILL RETURN AND DESPATCH THE FULL AMOUNT OR THE BALANCE OF THE APPLICATION MONIES, AS THE CASE MAY BE, WITHOUT INTEREST, TO YOU WITHIN TEN (10) MARKET DAYS FROM THE DATE OF THE FINAL BALLOT OF THE APPLICATION LISTS BY ORDINARY POST (IF YOUR APPLICATION IS FULLY UNACCEPTED) OR REGISTERED POST (IF YOUR APPLICATION IS PARTIALLY ACCEPTED) AT YOUR ADDRESS LAST MAINTAINED WITH THE DEPOSITORY.

YOUR REMITTANCES HAVING BEEN PRESENTED FOR PAYMENT SHALL NOT SIGNIFY THAT YOUR APPLICATION HAS BEEN ACCEPTED.

16.8 CDS Accounts

Pursuant to Section 29 of the Securities Industry (Central Depositories) Act, 1991, all dealings in our Company's shares will be by book entries through CDS accounts. We will not be issuing any share certificates to you.

You must have a CDS account for making an application for the Offer/Public Issue Shares by way of Application Form. You shall state your CDS account number in the space provided on the Application Form and by doing so, you shall be deemed to have authorised the Depository to disclose information pertaining to the CDS account to MIH/our Company. If you do not presently have a CDS account, you should open a CDS account at an ADA prior to making an application for the Offer/Public Issue Shares.

You must have a CDS account for making an application for the Public Issue Shares by way of Electronic Share Application. You shall furnish your CDS account number to the Participating Financial Institution by way of keying in your CDS account number if the instructions on the ATM screen at which you enter your Electronic Share Application require you to do so.
