NOTES TO THE INTERIM FINANCIAL REPORT FOR THE PERIOD ENDED 30 SEPTEMBER 2015 A. EXPLATORY NOTES PURSUANT TO MFRS 134

The shares repurchased are being held as treasury shares in accordance with Section 67A of the Companies Act 1965. None of the treasury shares held were resold or cancelled during the quarter under review and up to the date of this report.

A first and final single tier dividend of 3% amounting to RM1,963,292 in respect of financial year ended 31 December 2014 was approved by the shareholders at the Eighteenth Annual General Meeting and was paid to the shareholders on 21 August 2015.

Quarter results

The Group's revenue for the fourth quarter was RM51.9 million, a decrease of 15% over the performance of the preceding year corresponding quarter mainly due to weaker consumer spending. Correspondingly, profit before tax of RM6.5 million was also lower.

Financial Year-to-date results

For the financial year ended 31 December 2015, the Group posted a total revenue of RM191.4 million, which represent a decrease of 12.8% as compared with the previous year corresponding period of RM219.4 million. Profit before tax for the financial year-to-date of RM17.7 million was 35.8% lower than the previous year corresponding period-to-date of RM27.6 million due to lower sales and loss in foreign exchange.

B2. Material Changes in Current Quarter Results compared to Immediate Preceding Quarter

In the fourth quarter of 2015, the Group registered a revenue of RM51.9 million and profit before taxation of RM6.5 million versus a revenue of RM40.9 million and profit before taxation of RM0.5 million recorded in the immediate preceding quarter.

The better performance was in line with the cyclical trend of the Group, where festive and holiday seasons saw improvements in revenue.

B3. Prospects For Financial Year 2015

The economic and business environment will continue to be challenging with the dampened consumer sentiment and weaken Ringgit Malaysia.

The Group has taken steps to weather such challenging time which include streamlining its operations and redistributing its resources to increase it's efficiency besides closely monitoring of it's expenses. The Group expects satisfactory results.

The Group has not provided any profit forecast or profit guarantee.
