NOTES TO THE INTERIM FINANCIAL STATEMENTS FOR THE PERIOD ENDED 30 SEPTEMBER 2018

PART A: EXPLANATORY NOTES PURSUANT TO MFRS 134: INTERIM FINANCIAL REPORTING

A1 BASIS OF PREPARATION

The condensed consolidated interim financial statements are unaudited and have been prepared in accordance with MFRS 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and the requirements of the Companies Act 2016 in Malaysia, where applicable. This condensed consolidated interim financial statements has also been prepared in accordance with the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

This condensed consolidated financial statements, other than for financial instruments, freehold land and buildings, have been prepared under the historical cost convention. Certain financial instruments are carried at fair value in accordance with Malaysian Financial Reporting Standard ("MFRS") 9 Financial Instruments.

The condensed consolidated interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2017. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2017.

A3 AUDITORS' REPORT ON PRECEDING FINANCIAL STATEMENTS

There was no qualification on the audited financial statements for the Company or its subsidiaries for the financial year ended 31 December 2017.

A4 SEASONAL OR CYCLICAL FACTORS

The Cookware Division's revenue is subject to seasonality due to market demand and supply conditions. Historically, demand for the premium cookware and kitchenware generally increases in the second half of the year due mainly to the seasonal nature of consumer spending behaviour in the export markets, where the shopping seasons normally peak in the final guarter of the year during festive periods such as Christmas and New Year.

A5 CHANGES IN ESTIMATES

There were no changes in estimates of amounts reported in prior financial years that have a material effect in the current quarter and financial period ended 30 September 2018.

A6 UNUSUAL ITEMS DUE TO THE NATURE, SIZE OR INCIDENCE

There were no unusual items affecting the assets, liabilities, equity, net income or cash flows during the current quarter and financial period ended 30 June 2018.

A7 MATERIAL CHANGES IN ESTIMATES

There were no material changes in estimates that have a material effect on the results for the current quarter and financial period ended 30 September 2018.

A8 ISSUANCE OR REPAYMENT OF DEBT AND EQUITY SECURITIES

Save as disclosed below, there were no issuance and repayment of debt and equity securities, share buy-backs, share cancellation, warrant exercise for the current quarter and financial period ended 30 September 2018.

(a) Share Buy-backs

At the Annual General Meeting of the Company held on 28 June 2018, the shareholders of the Company had renewed a mandate for the Company to purchase and/or hold up to maximum of 10% of the issued share capital of the ordinary shares of the Company as may be determined by the Directors of the Company. The mandate will expire upon the conclusion of the next Annual General Meeting.

(a) Share Buy-backs (Cont.)

As at 30 September 2018, the total number of shares bought back and held as treasury shares were 26,978,200 ordinary shares, representing 8.4% of the total issued share capital of the Company. On 28 September 2018, the Company acquired 30,000 ordinary shares in the share capital of MyAngkasa Ni Hsin Sdn Bhd (now known as Ni Hsin Marketing Sdn Bhd) ("NHM"), representing the remaining 30% of the issued share capital of NHM from MyAngkasa Holdings Sdn Bhd, for a total cash consideration of RM1.00 only. Subsequent to the acquisition, NHM became a wholly-owned subsidiary of the Company.

NOTES TO THE INTERIM FINANCIAL STATEMENTS FOR THE FINANCIAL PERIOD ENDED 30 SEPTEMBER 2018

PART B: ADDITIONAL INFORMATION REQUIRED BY THE LISTING REQUIREMENTS OF BURSA SECURITIES

B1 OPERATING SEGMENTS REVIEW

Quarter Ended 30 September 2018 ("Q3 2018") vs Quarter Ended 30 September 2017 ("Q3 2017")

The Group's revenue and Profit Before Taxation ("PBT") were approximately RM8.54 million and RM6.10 million respectively for Q3 2018. Revenue in Q3 2018 slightly decreased by RM0.39 million or 4.3% compared with the revenue in Q3 2017, due to lower sales of convex mirrors and clad metals. The Group's gross profit ("GP") margin for Q3 2018 decreased to 15.6%, compared with GP margin of 27.19% achieved in Q3 2017. Other operating income increased to RM7.43 million in Q3 2018 mainly due to net gain in fair value of investment in quoted shares measured at fair value by the Company of RM7.14 million. Operating expenses in Q3 2018 remained consistent at RM2.64 million compared with Q3 2017. The Group recorded a PBT of RM6.10 million in Q3 2018 compared with RM0.37 million in Q3 2017. Consequently, the Group achieved a Profit After Taxation ("PAT") of RM6.17 million for Q3 2018 compared with RM0.26 million for Q3 2017.

9 Months Period Ended 30 September 2018 ("9M2018") vs 9 Months Period Ended 30 September 2017 ("9M2017")

The Group's performance by each Division for the financial period is as follows:

(i) Cookware Division

The Cookware Division's revenue for 9M2018 decreased by RM3.23 million or 22.8% to RM10.95 million compared with the revenue achieved in 9M2017 of RM14,18 million, as sales to the Asia Pacific countries (excluding Japan) and Japan during the 9M2018 has decreased by RM2.28 million and RM0.34 million respectively. The sales to USA and Cananda as well as Europe also decreased by RM0.46 million and RM0.16 million respectively. The cookware revenue by geographical market for 9M2018 is as follows:

(ii) Convex Mirror Division

The Convex Mirror Division achieved a revenue of RM7.77 million for 9M2018, a decrease of RM1.09 million compared with the revenue of RM8.86 million achieved in 9M2017. The decrease in revenue is attributable to lower export sales to Japan and Europe.

(iii) Clad Metal Division

Clad Metal Division's revenue decreased in 9M2018 by RM1.74 million to RM4.68 million compared with the revenue achieved in 9M2017 of RM6.42 million. Sales of clad metal decreased in 9M2018 mainly due to decreased orders from customers in Thailand and Europe markets.

B1 OPERATING SEGMENTS REVIEW (CONT.)

9 Months Period Ended 30 September 2018 ("9M2018") vs 9 Months Period Ended 30 September 2017 ("9M2017") (Cont.)

The Group's net assets per share as at 30 September 2018 stood at RM0.32. The Group's non-current assets increased to RM52.95 million compared with the non-current assets of RM53.24 million as at 31 December 2017 due to acquisition of new plant and equipment and mitigated with depreciation charges. Inventories increased to RM22.79 million as at 30 September 2018. Receivables, deposits and prepayments increased by RM1.66 million to RM5.62 million mainly due prepayments made for e-commerce and market development activities. The Group's net current assets was RM45.95 million as at 30 September 2018. The Group is in a positive net cash position as at 30 September 2018 with cash and cash equivalent of RM0.20 million after deducting all borrowings of the Group.

The Group's net operating cash outflow for 9M2018 was RM7.39 million. The net cash outflow from investing activities was RM13.45 million, mainly due to acquisition of quoted shares and purchase of plant and equipment. Net cash inflow from financing activities was RM13.47 million, mainly attributable to proceeds from exercise of warrants. The net resultant impact to the Group's cash flow was decrease in cash of RM7.37 million during 9M2018. Net cash and cash equivalents amounted to RM2.10 million as at 30 September 2018.

However, the Group recorded a PBT and perofit for the period in Q3 2018 due to net gain in fair value of investment in quoted shares measured at fair value by the Company of RM7.14 million during Q3 2018 as compared to Q2 2018.

Despite the challenging economic and business environment, the Directors are confident of the quality and innovative capabilities of the Group to meet the product and service requirements of the customers. Intensive efforts are being made to further develop and expand existing markets as well as to penetrate into new markets worldwide and the Directors expect the business prospects for 2019 and beyond to be positive.
