

MRCB-Quill REIT (MQREIT MK)

A decent 1Q20; BUY on yields

Maintain BUY with strong 10% net DPU yield

1Q20 core earnings came in within our expectations, at 25%/31% of our/consensus' full-year estimates. We maintain our earnings forecasts and DDM-TP of MYR1.19 (Ke: 7.2%). Maintain BUY. We believe impact from COVID-19 is limited while most of the near-term negatives at Platinum Sentral have been priced in. We also expect Menara Shell and its other single-tenanted offices to remain resilient. Our projected FY20-21 net DPU yield is a strong c.10% p.a.

Earnings growth led by occupancy improvements

1Q20 core net profit grew 2% YoY and 6% QoQ to MYR19.8m. The improved YoY earnings were mainly attributed to improved/sustained occupancies across most assets - notably Platinum Sentral (84%, -2ppt YoY), Menara Shell (99%, +9ppt), and Wisma Technip (90%, +26ppt). Overall, 1Q20 portfolio occupancy was recorded at 91% (+2ppt YoY).

Limited near-term negatives from COVID-19

We maintain our FY20-22 earnings estimates. We note that MQREIT has provided some rental support to selected tenants, namely at Plaza Mont Kiara (retail tenants), Platinum Sentral (selected SMEs and retail tenants) and Menara Shell (retail tenants). However, we understand that these recipients of rental support only represented an aggregate of single-digit percentage of NLA within MQREIT's portfolio (2.2m sqft NLA) and most of the rental support was only provided in Apr 2020. Hence, we anticipate some lower QoQ rental income, but limited, in 2Q20.

Outlook remains positive with favourable DPUs

We continue to favour MQREIT's mid to long-term earnings outlook, backed by properties with long-term tenants, i.e. Platinum Sentral, Menara Shell, QB1, QB4, QB2 and Tesco Building. These assets contribute c.51% to our FY20-22E revenue. Elsewhere, we are projecting FY20-22E net DPUs of 6.5-6.7sen, based on 96-98% payout ratio. These translate into strong net DPU yields of 9-10%. Meanwhile, based on a worst case scenario with 90% payout ratio, theoretical net DPU yields are still at a high c.9% p.a.

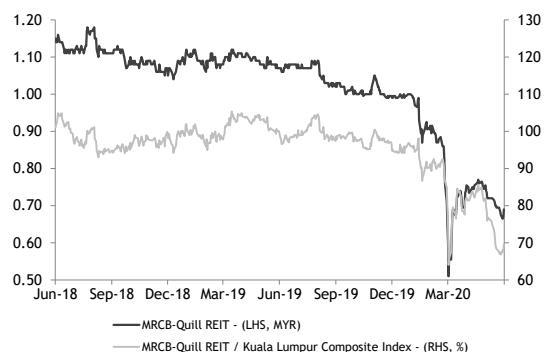

Risk statement

There are several risk factors for our earnings estimates, target price and rating for MQREIT. Changes in rental rates, occupancy rates, operating expenses and interest rates may lead to lower earnings for MQREIT. 19% of MQREIT's total NLA is due for lease renewal in 2020 while 54% of MQREIT's total debt is based on floating rates. Another earnings risk would be if the impact from COVID-19 becomes prolonged.

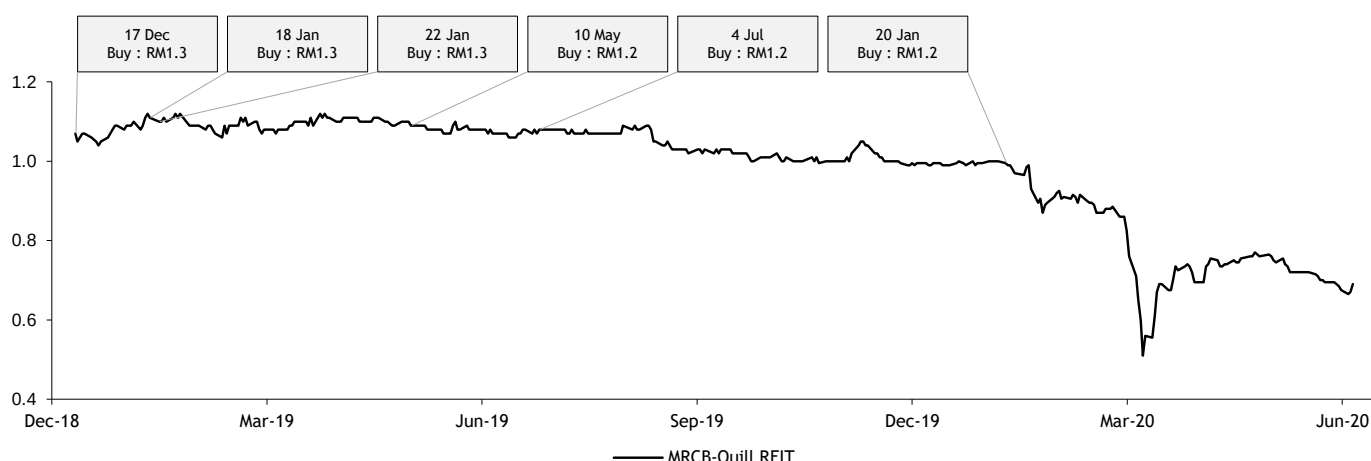
