For the current financial quarter ended 31 March 2021, the Group recorded lower revenue of RM11.63 million and a lower profit before tax of RM1.80 million as compared to revenue of RM18.60 million and profit before tax of RM3.24 million respectively in the immediate preceding financial quarter ended 31 December 2020.

The decrease is mainly due to lower demand for our products due to the reintroduction of the movement control order ("MCO") from 13 January 2021 which has resulted in delayed in our scheduled deliveries of products.

B3. Prospects and outlook

The recent outbreak of the COVID-19 virus since the end of 2019 had disrupted the global operating environments and restricting global travelling and the outbreak had soften economic growth both in Malaysia and internationally.

The World Health Organisation had on 11 March 2020 declared the outbreak to be a pandemic and the Malaysian Government had imposed the MCO commencing 18 March 2020 and has been extended to 20 May 2021. The measures undertaken by the Government, such as international and domestic travel restrictions, control of non-essential services, reduced operating hours and work force, are necessary to curb and slow down the spread of the COVID-19.

Whilst the Government has gradually eased the restriction and businesses are allowed to operate under strict standard operating procedures, the recovery of our economy, as well as the return to our normal social behaviour will require more time and efforts from all stakeholders.

With the current uncertainty in the local and international economy due to the COVID-19 outbreak, the performance of the Group for the financial year ending 31 March 2021 will remain challenging. However, the Group will exercise extra vigilance in the business and will strive to deliver satisfactory performance for the year despite the COVID-19 pandemic.

The Group has on 18 December 2020 entered into a joint venture agreement with Samdo Smart Solar (M) Sdn Bhd to jointly procure the completion of the service of engineering, procurement, construction and commissioning ("EPCC") in respect of only six (6) solar power systems for telecommunication towers located in Peninsular and East Malaysia which will provide recurring income as a source of our business income.
