# Radiant Group rides on gradual retail recovery

- 1H21 net profit improves to RM3.2 million from Movement Control Order (MCO) impact a year ago
- Retail and industrial software solutions well-positioned to support digitalisation of businesses; to ride recovery trend

Kuala Lumpur, Malaysia, 23 August 2021 - Integrated technology solutions provider Radiant Globaltech Berhad, (Radiant Group, the Group, 锐腾有限公司, Bloomberg: 0202:MK) rode on the gradual retail and industrial recovery to report improved net profit of RM3.2 million for the six months period ended 30 June 2021 (1H21) from a net loss of RM0.5 million a year ago, as revenue grew 134.2% to RM62.1 million.

Radiant Group, which provides hardware and software to industrial companies and retail players such as convenience store and departmental store chains, reported 160.0% higher revenue from the Hardware and Maintenance segment to RM55.5 million in 1H21.

The balance of RM6.6 million came from the Software segment which grew 27.9% year-on-year.

"We posted a commendable rebound from the MCO-impacted first half of last year, as the retail sector recorded higher activity in terms of higher hardware sales, and steady income from the software segment. The pandemic accelerated demand for digitalisation, as businesses strive for greater efficiency, safety, and reduced reliance on manual processes.

Simultaneously, we are well positioned to ride the economic recovery going forward, as the country implements gradual easing of restrictions in various sectors under the National Recovery Plan.

We have the products and capabilities to support both physical outlets and e-commerce platforms, such as the AX B2B Platform, PosPlus F&B software and ARMS POS Retail Management software. We are confident of securing more customers on board this year which will enhance our performance going forward."
