- 1. ACE Holdings Berhad [Registration No. 199201001872 (233376-H)] ("ACE") is a substantial shareholder of APEX via ACE Credit (M) Sdn Bhd;
- Dato' Calvin Choong Chee Meng is the current Group Managing Director of APEX;
- 3. Dato' Celine Leong Wai Leng is the current Deputy Group Managing Director of APEX:
- 4. Mr. Lim Kok Eng is an Executive Director of APEX;
- 5. Ms. Annie Chang Ai Nee is the current Strategic Advisor of APEX;
- 6. Mr. Woon Wai En is a Director of APEX;
- 7. Mr. Lee Siow Hong is a Director of APEX;
- 8. Mr. Kevin Wong Zhen Fai is an employee of APEX carrying the designation of a Director in the Managing Director's Office;
- 9. Mr. Chang Min De is an employee of APEX carrying the designation of a Director in the Deputy Managing Director's Office;

- 10. Mr. Leong Kok Hoong is an employee of APEX carrying the designation of Group Corporate Resources Director; and

- (1) Paragraph 7.02(1), (2) and (3) of the Licensing Handbook read together with Paragraph 4.02 of the Licensing Handbook where Apex Securities Berhad was alleged to have failed to remain fit and proper as a CMSL holder; and
- (2) Section 64(1)(h)(iia) of the Capital Markets and Services Act 2007 ("CMSA") read together with section 72(2)(a)(i) of the CMSA which provides that the CMSL of Apex Securities may be revoked if a controller of Apex Securities has been subjected to an action under section 354, 355 and 356 of the CMSA; and
- (3) Section 64(1)(h)(iv) of the CMSA read together with section 72(2)(a)(i) of the CMSA which provides that the CMSL of Apex Securities may be revoked if a controller of Apex Securities has engaged in any business practices appearing to the SC to be improper (whether unlawful or not).

ACE:

Pursuant to the sanction imposed by the SC on ACE under section 354 of the CMSA, ACE is aware or ought to be aware that it is not a fit or proper person to be a controller of Apex Securities Berhad, whether directly or indirectly. Accordingly, ACE which continues to assume the role of a controller of Apex Securities Berhad, whether directly or indirectly, is a person who appears to have been knowingly involved in the contravention(s) committed by Apex Securities Berhad.
