AMENDMENTS, VARIATIONS AND SUPPLEMENTAL TERMS TO THE ESCROW AGREEMENT

1. Amendment to Clause 2 of the Escrow Agreement

- (a) The insertion of a new a new Clause 2.3, which shall read as follows:

“2.3 Pursuant to Clause 4.2(a)(ii) of this Escrow Agreement, the RCPS Certificates shall be delivered to the Escrow Agent’s affiliate firm in Malaysia, KhaiLing Yau Chambers at the following address:

2. Amendment to Clause 4.2 (a)(ii) of the Escrow Agreement

- (b) The deletion of Clause 4.2(a)(ii) in its entirety and inserting the following new Clause 4.2(a)(ii) in substitution thereof:

“(ii) Upon receipt of each RCPS Certificate, we shall keep such RCPS Certificate at the premises of our affiliate firm in Malaysia, KhaiLing Yau Chambers until the earlier of (A) the Maturity Date; or (B) the last day of the Escrow Period, upon which we reserve the right to return such RCPS Certificate to the Subscribers (or their nominees) but without prejudice to our Fees payable by the Company and our rights set out in this Escrow Agreement.”

3. Amendment to Clause 5 of the Escrow Agreement

- (a) The deletion of Clause 5.1 in its entirety and inserting the following new Clause 5.1 in substitution thereof:

“5.1 All notices delivered hereunder shall be in writing in English and shall be communicated to the address and/or to the email address of the party and addressed for the attention of the relevant person as specified below:
