Meanwhile, AGMO will develop and maintain the Model, overseeing its architecture, dataset integration, and performance optimisation. AGMO will also provide ongoing technical support, including system setup, troubleshooting, user training, and regular updates to enhance the Model with new data and technology advancements. The Model will be fine-tuned on DeepSeek and leverage state-of-the-art AI techniques to improve accuracy, contextual understanding, and user interaction.

Both parties will collaborate on marketing and promotional efforts to drive adoption across the education and corporate sectors. By leveraging their respective networks and expertise, SASBADI and AGMO aim to create user-friendly, Al-driven education solutions that enhance student engagement, improve teaching processes, and foster digitally proficient learners.

This collaboration aligns with the goals of the Digital Education Policy and the Malaysia Digital Economy Blueprint, ensuring equitable access to high-quality educational resources for all. It underscores both companies' commitment to providing culturally relevant, contextually accurate, accountable and safe Al solutions for Malaysia's educators and students. Furthermore, this collaboration also contributes to Malaysia's efforts in achieving data sovereignty.
