Precautionary Measures Against the Coronavirus Disease 2019 ("COVID-19")

- The Securities Commission Malaysia ("SC") had on 13 January 2021 announced that capital market entities supervised, licensed or registered by the SC shall operate in accordance with the applicable Standard Operating Procedures ("SOPs") issued by the authorities during the Emergency Ordinance and various forms of Movement Control Order ("MCO"). The SC had on 19 February 2021 issued a revised Guidance Note on the Conduct of General Meetings for Listed Issuers ("SC Guidance Note") which states that only fully virtual meetings will be allowed during MCO and Conditional MCO, subject to the requirements under the prevailing and applicable SOPs.
- In line with the Government of Malaysia's directive and SC Guidance Note above, to curb the spread of COVID-19, the Company will conduct the EGM on a fully virtual basis through live streaming and online remote voting via the Remote Participation and Voting ("RPV") facilities which are available on Tricor Investor & Issuing House Services Sdn Bhd's ("Tricor") TIIH Online website at https://tiih.online.
- The broadcast venue of the EGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the meeting to be at the main venue of the meeting. No shareholder(s)/proxy(ies) from the public will be physically present at the broadcast venue of the EGM.
- We strongly encourage you to attend the EGM via the RPV facilities. You may also consider appointing the Chairman of the EGM as your proxy to attend and vote on your behalf at the EGM.
- Due to the constant evolving COVID-19 situation in Malaysia, the Company may be required to change the arrangements of the EGM on short notice.
