Mode of Meeting

- The 25th AGM of Pharmaniaga Berhad will be conducted on a virtual basis through live streaming whilst the online remote voting will be via Remote Participation and Voting (RPV). Both facilities are available on Tricor Investor & Issuing House Services Sdn Bhd's TIIH Online website at https://tiih.online.
- The venue of the AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be at the main venue of the meeting. No shareholders/proxy(ies) from the public will be physically present at the meeting venue.

Remote Participation and Voting

- Shareholders are to participate (including posing questions to the Board via real time submission of typed texts) and vote remotely at the AGM via the RPV provided by Tricor via its TIIH Online website at https://tiih.online.
- Shareholders who appoint proxy(ies) to participate via RPV in the AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than Saturday, 10 June 2023 at 2.30 p.m. to participate via RPV in the AGM.
- Corporate representatives of corporate members must deposit their original certificate of appointment
 of corporate representative to Tricor no later than Saturday, 10 June 2023 at 2.30 p.m. to participate via
 RPV in the AGM. Attorneys appointed by power of attorney are to deposit their power of attorney with
 Tricor not later than Saturday, 10 June 2023 at 2.30 p.m. to participate via RPV in the AGM.
- A shareholder who has appointed a proxy or attorney or authorized representative to participate at the AGM via RPV must request his/her proxy to register himself/herself for RPV at TIIH Online website at https://tiih.online.
- As the AGM is a virtual meeting, members who are unable to participate in the Meeting may appoint the Chairman of the Meeting as his/her proxy and indicate the voting instructions in the proxy form.

Procedures to Remote Participation and Voting via RPV Facilities

• Please read and follow the procedures below to engage in remote participation through live streaming and online remote voting at the AGM using the RPV facilities:

i. Register as a user with TIIH Online	 Using your computer, access to website at https://tiih.online. Register as a user under the "e-Services", select the "Sign Up" button and followed by "Create Account by Individual Holder". Refer to the tutorial guide posted on the homepage for assistance.
	Registration as a user will be approved within one (1) working day and you will be notified via e-mail.
	• If you are already a user of TIIH Online, you are not required to register again. You will receive an e-mail to notify you that remote participation is available for registration at TIIH Online.
ii. Submit your request to attend AGM remotely	 Registration is open from Friday, 12 May 2023 until the day of the AGM on Monday, 12 June 2023. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the AGM to ascertain their eligibility to participate in the AGM using the RPV.
	 Login with your user ID (i.e. email address) and password and select the corporate event: "(REGISTRATION) PHARMANIAGA 25TH AGM".
	 Read and agree to the Terms & Conditions and confirm the Declaration.
	Select "Register for Remote Participation and Voting".
	Review your registration and proceed to register.
	System will send an email to notify you that your registration for remote participation is received and will be verified.
	 After verification of your registration against the Record of Depositors as at 6 June 2023, the system will send you an e-mail on or after 10 June 2023 to approve or reject your registration for remote participation.
	(Note: Please allow sufficient time for approval of new users of TIIH Online and registration for the RPV).

On the AGM Day

Procedure	Action
i. Login to TIIH Online	• Login with your user ID and password for remote participation at the 25th AGM at any time from 1.30 p.m. i.e. 1 hour before the commencement of meeting at 2.30 p.m. on Monday, 12 June 2023.
ii. Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) PHARMANIAGA 25TH AGM" to engage in the proceedings of the AGM remotely. If you have any questions for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will try to respond to questions submitted by remote participants during the AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
iii.Participate through Live Streaming	 Voting session commences from 2.30 p.m. on Monday, 12 June 2023 until a time when the Chairman announces the completion of the voting session at the 25th AGM. Select the corporate event: "(REMOTE VOTING) PHARMANIAGA 25TH AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
iv.End of remote participation	Upon the announcement by the Chairman on the conclusion of the AGM, the Live Streaming will end.

Note to users of the RPV facilities:

- 1. We will make available to you the rights to join the live stream meeting and to vote remotely once your application to join the meeting is approved. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.
- 3. Entitlement to Participate and Appointment of Proxy

- Only members whose names appear on the Record of Depositors as at 6 June 2023 shall be eligible to attend, speak and vote at the AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Proxy Form.
- If you wish to participate in the AGM yourself, please do not submit any Proxy Form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you.

Voting at Meeting

- The voting at the AGM will be conducted on a poll pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia"). The Company has appointed Tricor to conduct the poll voting electronically ("e-voting") via Tricor e-vote application ("Tricor e-Vote App").
- Shareholders can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and submit your votes at any time from the commencement of the AGM at 2.30 p.m. Kindly refer to "Procedures to Remote Participation and Voting via RPV Facilities" provided above for guidance on how to vote remotely via TIIH Online.
