1. Registration on the day of the 11th AGM

- 1. Registration will commence at 9.00 a.m.
- 2. Please present your original National Registration Identity Card (NRIC) or Passport to the registration staff for verification and a voting slip will be given to you thereafter.
- 3. Registration must be done in person. No person is allowed to register on behalf of another.
- 4. The registration counter will handle verification of identity, registration and revocation of proxy(ies).

2. CORPORATE MEMBERS

- 1. Corporate members who wish to appoint corporate representatives instead of a proxy, must deposit their original or duly certified certificate of appointment of corporate representative to Tricor on or before the AGM.
- 2. Attorneys appointed by power of attorney are required to deposit their power of attorney with Tricor not later than **Monday**, **25 September 2023 at 10.00 a.m.** to attend and vote at the 11th AGM.

3. GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

1. Only a depositor whose name appears on the ROD as at **20 September 2023** shall be entitled to attend, participate, speak and vote at the <u>116</u>th AGM or appoint proxies to attend and/or vote on his/her behalf.

4. <u>PROXY</u>

- You may submit your proxy form to Tricor Investor & Issuing House Services Sdn Bhd at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, not less than forty-eight (48) hours before the time appointed for holding the 11th AGM or any adjournment thereof, otherwise the proxy form shall not be treated as valid.
- 2. Alternatively, you may also submit the proxy form electronically via TIIH Online website at https://tiih.online, not later than Monday, 25 September 2023 at 10.00 a.m. Please do read and follow the procedures below to submit proxy form electronically.

Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote. Review and confirm your proxy(s) appointment. Print proxy form for your record.

Complete the registration form and upload the required documents. Registration will be verified, and you will be notified by email within one (1) to two (2) working days. Proceed to activate your account with the temporary password given in the email and re-set your own password. Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder
