**ADJUSTMENTS TO THE EXERCISE PRICE AND NUMBER OF OUTSTANDING WARRANTS C AS SPECIFIED IN THE DEED POLL C PURSUANT TO THE SHARE CONSOLIDATION**

**1. INTRODUCTION**

On 23 August 2023, TA Securities had, on behalf of the Board, announced that the Company proposes to undertake the Share Consolidation.

On 7 September 2023, TA Securities had, on behalf of the Board, announced that Bursa Securities had vide its letter dated 6 September 2023 approved the Share Consolidation.

The shareholders of the Company had, during the EGM held on 9 October 2023, approved the Share Consolidation.

On 10 October 2023, TA Securities had, on behalf of the Board, announced that the Entitlement Date for the Share Consolidation has been fixed at 5.00 p.m. on 25 October 2023. The Warrants C Holders whose name appears in the Record of Depositors for the Warrants C on the Entitlement Date would be entitled to the Adjustments.

**THE PURPOSE OF THIS NOTICE IS TO PROVIDE YOU WITH INFORMATION PERTAINING TO THE ADJUSTMENTS. THIS NOTICE SETS OUT PARTICULARS OF THE EVENTS GIVING RISE TO THE ADJUSTMENTS, TOGETHER WITH THE COMPUTATION AND THE EFFECTIVE DATE OF THE ADJUSTMENTS. NO ACTION IS REQUIRED TO BE TAKEN ON YOUR PART.**

## 2. DETAILS OF THE ADJUSTMENTS

Based on the Record of Depositors for Warrants C as at the Entitlement Date, there are 305,864,459 outstanding Warrants C.

In accordance with the provisions of the Deed Poll C, the Board, in consultation with TA Securities, sets out below the detailed computations of the Adjustments to the exercise price and number of outstanding Warrants C consequential to the Share Consolidation, which have been duly certified by the Auditors:

$$\text{Adjusted exercise price of Warrants C} = \frac{\text{Existing exercise price of Warrants C} \times Y}{Z}$$

$$\text{Adjusted number of Warrants C} = \frac{\text{Existing number of Warrants C} \times Z}{Y}$$

where:

Y = The aggregate number of issued Komarkcorp Shares immediately before the Share Consolidation

Z = The aggregate number of issued Komarkcorp Shares immediately after the Share Consolidation

Following the above, the Share Consolidation shall give rise to the following adjustments:

$$\text{Adjusted exercise price of Warrants C} = \frac{\text{RM0.43} \times 1,154,613,338}{230,922,667^{(1)}}$$

$$= \text{RM2.15}$$

$$\text{Adjusted number of Warrants C} = \frac{305,864,459 \times 230,922,667^{(1)}}{1,154,613,338}$$

$$= \text{61,172,891}^{(2)}$$

### Notes:

(1) Fractional entitlements arising from the Share Consolidation have not been considered.

(2) Rounded down to the nearest whole Warrants C in accordance with the provisions of the Deed Poll C.

Based on the above computation, the adjusted number of Warrants C is 61,172,891. Notwithstanding the above, the fractional entitlements arising from the Adjustments were disregarded, hence resulting in the actual adjusted number of Warrants C pursuant to the Adjustments is 61,171,463.

In summary, the details of the Adjustments are set as follows:

Save for the Adjustments mentioned above, the rights and obligations of the Warrant C Holders remain unchanged.

### 3. RATIONALE FOR THE ADJUSTMENTS

The Adjustments have been made in accordance to the provisions of the Deed Poll C in order to ensure the status of Warrants C Holders is not prejudiced after the implementation of the Share Consolidation.

### 4. EFFECTIVE DATE OF THE ADJUSTMENTS

In accordance with the provisions of the Deed Poll C, the Adjustments took effect on 26 October 2023, being the next Market Day following the Entitlement Date. The Additional Warrants C arising from the Adjustments were listed and quoted on the Main Market of Bursa Securities on 26 October 2023 simultaneously with the Consolidated Shares.

### 5. CONSENTS

TA Securities and Moore Stephens have given and have not subsequently withdrawn their written consents to the inclusion of their names and all references thereto in the form and context in which they appear in this Notice.

### 6. DIRECTORS' RESPONSIBILITY STATEMENT

This Notice has been seen and approved by the Board and the Directors collectively and individually accept full responsibility for the completeness and accuracy of the information contained in this Notice and confirm that after making all reasonable enquiries and to the best of their knowledge and belief, there are no false and misleading statements contained in this Notice or other facts, the omission of which would make any statement in this Notice false or misleading.
