MODE OF MEETING

In line with the Government's directive and the revised Guidance Note and Frequently Asked Questions (FAQs) on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 7 April 2022 ("SC Guidance"), the EGM of the Company will be conducted on a fully virtual basis and via remote participation and voting facilities through live streaming from the Broadcast Venue.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairman of the meeting to be present at the main venue of the meeting and in accordance with Clause 61 of the Company's Constitution. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) **WILL NOT BE ALLOWED** to be physically present at the Broadcast Venue on the day of the Meeting.

REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

Shareholders are to attend, participate, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the EGM using the RPV facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") via its TIIH Online website at https://tiih.online.

A shareholder who has appointed a proxy or attorney or authorised representative to participate at this EGM via RPV facilities must request his/her proxy or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at https://tiih.online.

As the EGM will be held as a fully virtual meeting, shareholders who are unable to participate in this EGM via RPV facilities may appoint the Chairman of the Meeting as his/her proxy and indicate the voting instructions in the proxy form.

		 Registration as a user will be approved within one (1) working day and you will be notified of the status of registration via email. If you are already a user of TIIH Online, you are not required to register again. You will receive an e-mail to notify you that remote participation is available for registration at TIIH Online.
(b)	Submit your registration for RPV	 Registration is open from Tuesday, 28 November 2023 until the day of the EGM on Wednesday, 13 December 2023. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the EGM to ascertain their eligibility to participate in the EGM using the RPV. Login with your user identification ("ID") i.e. email address and password and select the corporate event: "(REGISTRATION) AWC EGM 2023". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. The system will send an e-mail to notify you that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors dated 6 December 2023, the system will send you an e-mail after 11 December 2023 to approve or reject your registration for remote participation and the procedures to use the RPV are detailed therein. In the event your registration is not approved, you will also be notified via email. (Note: Please ensure to allow the sufficient time required for the approval as a new user of TIIH Online as well as the registration for RPV in order for you to login to TIIH Online and to participate in the EGM remotely).

(d)	Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) AWC EGM 2023" to engage in the proceedings of the EGM remotely. If you have any questions for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavour to respond to questions submitted by the remote participant during the EGM. If there is a time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
(e)	Online Remote Voting	 The voting session commences from 10:00 a.m. on Wednesday, 13 December 2023 until a time when the Chairman announces the end of the session. Select the corporate event: "(REMOTE VOTING) AWC EGM 2023" or if you are on the live stream meeting page, you can select the "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the Central Depository System ("CDS") account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	Upon the announcement by the Chairman on the closure of the EGM, the live streaming will end.

Note to users of the RPV Facilities

- 1. Should your registration for RPV be approved we will make available to you the rights to join the livestreamed meeting and to vote remotely. Your login to TIIH Online on the day of the Meeting will indicate your presence at the virtual EGM.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

ENTITLEMENT TO PARTICIPATE / GENERAL MEETING RECORD OF DEPOSITORS

Only a depositor whose name appears on the record of depositors as at 6 December 2023 shall be entitled to participate at the EGM or appoint proxy(ies)/corporate representative(s)/attorney(s) to participate on his/her behalf.

APPOINTMENT OF PROXY OR ATTORNEY OR CORPORATE REPRESENTATIVE

Shareholders who appoint proxy(ies) to participate via RPV at the EGM must ensure that the duly executed proxy forms are deposited in a hard copy form to Tricor no later than **Monday**, **11 December 2023 at 10:00 a.m.**

The appointment of a proxy may be made in a hard copy form or by electronic means in the following manner:-

Any authority pursuant to which such an appointment is made by a power of attorney must be deposited with the Share Registrar of the Company at Tricor Investor & Issuing House Services Sdn. Bhd., Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8 Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia no later than Monday, 11 December 2023 at 10:00 a.m. to participate via RPV in the EGM. A copy of the power of attorney may be accepted provided that it is certified by a notary and/or in accordance with the applicable legal requirements in the relevant jurisdiction in which it is executed.

For a corporate member who has appointed a representative, please deposit the ORIGINAL/DULY CERTIFIED certificate of appointment with the Share Registrar of the Company at Tricor Investor & Issuing House Services Sdn. The certificate of appointment should be executed in the following manner:-

(i) If the corporate member has a common seal, the certificate of appointment should be executed under seal in accordance with the constitution of the corporate member.

- (ii) If the corporate member does not have a common seal, the certificate of appointment should be affixed with the rubber stamp of the corporate member (if any) and executed by:
 - (a) at least 2 authorised officers, of whom one shall be a director; or
 - (b) any director and/or authorised officers in accordance with the laws of the country under which the corporate member is incorporated.

Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) can proceed to vote on the resolution at any time **from 10:00 a.m. on Wednesday, 13 December 2023** but before the end of the voting session which will be announced by the Chairman of the Meeting. Upon completion of the voting session for the EGM, the Scrutineers will verify the poll results followed by the Chairman's declaration of whether the resolution are duly passed.
