#### MODE OF MEETING

The EGM will be conducted fully virtual through live streaming at the Online Meeting Platform as provided above.

According to the Revised Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 7 April 2022, an online meeting platform located in Malaysia is recognised as the meeting venue and all meeting participants of a fully virtual general meeting are required to participate in the meeting online.

# **REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES**

The RPV facilities are available on Tricor's **TIIH Online** website at https://tiih.online.

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the EGM using RPV facilities from Tricor.

Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

#### Procedures to Remote Participation and Voting via RPV Facilities

ii.	Submit your request to attend EGM remotely	<ul> <li>Registration is open from Wednesday, 31 January 2024 until the day of EGM on Thursday, 22 February 2024. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to preregister their attendance for the EGM to ascertain their eligibility to participate the EGM using the RPV.</li> <li>Login with your user ID (i.e. email address) and password and select the corporate event: "(REGISTRATION) PTRANS 2024 EGM".</li> </ul>

• Read and agree to the Terms & Conditions and confirm the
Declaration.
Select "Register for Remote Participation and Voting".
<ul> <li>Review your registration and proceed to register.</li> </ul>
<ul> <li>System will send an email to notify that your registration for remote participation is received and will be verified.</li> </ul>
<ul> <li>After verification of your registration against the Record of Depositors as at 16 February 2024, the system will send you an e-mail on or after</li> </ul>
<b>20 February 2024 to approve or reject</b> your registration for remote participation.
(Note: Please allow sufficient time for approval of new user of TIIH Online
and registration for the RPV.)

## On the EGM Day

i. Login to TIIH Online	• Login with your user ID and password for remote participation at the EGM at any time from 8.00 a.m. i.e. 1 hour before the commencement of meeting at 9.00 a.m. on Thursday, 22 February 2024.
ii. Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) PTRANS 2024 EGM" to engage in the proceedings of the EGM remotely.</li> <li>If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will try to respond to questions submitted by remote participants during the EGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li> </ul>
iii. Online remote voting	<ul> <li>Voting session commences from 9.00 a.m. on Thursday, 22 February 2024 until a time when the Chairman announces the end of the session.</li> <li>Select the corporate event: "(REMOTE VOTING) PTRANS 2024 EGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your vote.</li> </ul>
iv. End of remote participation	Upon the announcement by the Chairman on the conclusion of the EGM, the Live Streaming will end.

#### Note to users of the RPV facilities:

- 1. Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.
- 3. #### **Entitlement to Participate and Appointment of Proxy**

- Only members whose names appear on the Record of Depositors as at 16 February 2024 shall be eligible to attend, speak and vote at the EGM or appoint a proxy(ies) or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the EGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the EGM yourself, please do not submit any Form of Proxy for the EGM. You will not be allowed to participate in the EGM together with a proxy appointed by you.
- Accordingly, Form of Proxy and/or documents relating to the appointment of proxy/corporate representative/attorney for the EGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than **Tuesday**, **20 February 2024 at 9.00 a.m.**:

Register as a User with TIIH Online	<ul> <li>Access TIIH Online at https://tiih.online.</li> <li>Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects the "Sign Up" button and followed by "Create Account by Representative of Corporate Holder".</li> <li>Complete the registration form and upload the required documents.</li> <li>Registration will be verified, and you will be notified by email within one (1) to two (2) working days.</li> <li>Proceed to activate your account with the temporary password given in the email and re-set your own password.</li> <li>(Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration.)</li> </ul>	
Proceed with submission of Form of Proxy	<ul> <li>Login to TIIH Online at https://tiih.online.</li> <li>Select the corporate exercise name: "PTRANS 2024 EGM - SUBMISSION OF PROXY FORM".</li> <li>Agree to the Terms &amp; Conditions and Declaration.</li> <li>Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein.</li> <li>Prepare the file for the appointment of proxies by inserting the required data.</li> <li>Login to TIIH Online, select corporate exercise name: "PTRANS 2024 EGM - SUBMISSION OF PROXY FORM".</li> <li>Proceed to upload the duly completed proxy appointment file.</li> <li>Select "Submit" to complete your submission.</li> <li>Print the confirmation report of your submission for your record.</li> </ul>
