### MODE OF MEETING

The 15<sup>th</sup> AGM will be conducted on a fully virtual basis through live streaming and online meeting platform as well as online remote voting via the Remote Participation and Voting facilities ("RPV") provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") via its TIIH Online website at https://tiih.online.

### **REMOTE PARTICIPATION AND VOTING FACILITIES**

Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 15<sup>th</sup> AGM via the RPV provided by Tricor via its TIIH Online website at <u>https://tiih.online</u>.

Members who appoint proxies to participate via RPV in the 15<sup>th</sup> AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Sunday**, **2 June 2024 at 2.30 p.m.** 

Authorised representatives of corporate members must deposit their original certificate of appointment of authorised representative to Tricor to participate via RPV in the 15<sup>th</sup> AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **Sunday, 2 June 2024 at 2.30 p.m.** to participate via RPV in the 15<sup>th</sup> AGM.

A member who has appointed a proxy or attorney or authorised representative to participate at this 15<sup>th</sup> AGM via RPV must request his/her proxy/representative to register himself/herself for RPV at TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

As the 15<sup>th</sup> AGM is a fully virtual AGM, members who are unable to participate in this AGM may appoint the Chairperson of the meeting as his/her proxy and indicate the voting instructions in the proxy form.
