NOTES TO THE INTERIM FINANCIAL STATEMENTS FOR THE PERIOD ENDED 30 JUNE 2017**PART A: EXPLANATORY NOTES PURSUANT TO MFRS 134: INTERIM FINANCIAL REPORTING****A1 BASIS OF PREPARATION**

This condensed consolidated financial statements, other than for financial instruments, freehold land and buildings, have been prepared under the historical cost convention. Certain financial instruments are carried at fair value in accordance with Malaysian Financial Reporting Standard ("MFRS") 9 Financial Instruments.

The condensed consolidated interim financial statements are unaudited and have been prepared in accordance with MFRS 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

The condensed consolidated interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2016. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2016.

A2 SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies and methods of computation applied in the unaudited condensed consolidated interim financial statements are consistent with those adopted in the most recent annual financial statements for the year ended 31 December 2016, except for the following:

(a) Adoption of the Amendments to MFRS during the current financial yearEffective for annual periods commencing on or after 1 January 2017

Amendments to MFRS 107 Statement of Cash Flows - *Disclosure Initiative*

Amendments to MFRS 112 Income Taxes - *Recognition of Deferred Tax Assets for Unrealised Losses*

Amendments to MFRS 12 Disclosure of Interests in Other Entities (*Annual Improvements to MFRSs 2014 - 2016 Cycle*)

The above pronouncements are either not relevant or do not have any impact on the financial statements of the Group, except for the Amendments to MFRS 107 Statement of Cash Flows - Disclosure Initiative.

These amendments to MFRS 107 Statement of Cash Flows require the entity to disclose a reconciliation between the opening and closing balances for liabilities arising from financing activities, including both changes arising from cash flows and non-cash flow changes. The adoption of these amendments does not require additional disclosure in the condensed report, but such disclosure will be required in the annual financial statements.

The Group will adopt the above pronouncements when they become effective in the respective financial periods. Due to the complexity of the standard and its requirements, the financial effects of its adoption are still being assessed by the Group.

(b) Companies Act 2016

The Companies Act 2016 ("New Act") was enacted to replace the Companies Act, 1965 with the objectives to create a legal and regulatory structure that will facilitate business, and promote accountability as well as protection of corporate directors and shareholders, taking into consideration the interest of other stakeholders. The New Act was passed on 4 April 2016 by the Dewan Rakyat (House of Representative) and gazetted on 15 September 2016. On 26 January 2017, the Minister of Domestic Trade, Co-operatives and Consumerism announced that the date on which the New Act comes into operation, except section 241 and Division 8 of Part III of the New Act, will be 31 January 2017.

Amongst the key changes introduced in the New Act which will affect the financial statements of the Group and of the Company upon the commencement of the New Act on 31 January 2017 includes:

- (a) removal of the authorised share capital;
- (b) shares of the Company will cease to have par or nominal value; and
- (c) the Company's share premium account will become part of the Company's share capital.

During the period, the Company had transferred a total of RM1,820,000 from its share premium account to the share capital pursuant to the New Act.

The adoption of the New Act did not have any financial impact on the Group and the Company for the current financial year as any accounting implications will only be applied prospectively, if applicable, and the effect of adoption mainly will be on disclosures to the annual report and financial statements for the financial year ending 31 December 2017.

A3 AUDITORS' REPORT ON PRECEDING FINANCIAL STATEMENTS

There was no qualification on the audited financial statements for the Company or its subsidiaries for the financial year ended 31 December 2016.

A4 SEASONAL OR CYCLICAL FACTORS

The Cookware Division's revenue is subject to seasonality due to market demand and supply conditions. Historically, demand for the premium cookware and kitchenware generally increases in the second half of the year due mainly to the seasonal nature of consumer spending behaviour in the export markets, where the shopping seasons normally peak in the final quarter of the year during festive periods such as Christmas and New Year.

A5 CHANGES IN ESTIMATES

There were no changes in estimates of amounts reported in prior financial years that have a material effect in the current quarter ended 30 June 2017.

A6 UNUSUAL ITEMS DUE TO THE NATURE, SIZE OR INCIDENCE

There were no unusual items affecting the assets, liabilities, equity, net income or cash flows during the current quarter and financial period ended 30 June 2017.

A7 MATERIAL CHANGES IN ESTIMATES

There were no material changes in estimates that have a material effect on the results for the current quarter and financial period ended 30 June 2017.

A8 ISSUANCE OR REPAYMENT OF DEBT AND EQUITY SECURITIES

Save as disclosed below, there were no issuance and repayment of debt and equity securities, share buy-backs, share cancellation, warrant exercise for the current quarter and financial period ended 30 June 2017.

(a) Share Buy-backs

At the Annual General Meeting of the Company held on 23 June 2017, the shareholders of the Company had renewed a mandate for the Company to purchase and/or hold up to maximum of 10% of the issued share capital of the ordinary shares of the Company as may be determined by the Directors of the Company. The mandate will expire upon the conclusion of the next Annual General Meeting.

As at 30 June 2017, the total number of shares bought back and held as treasury shares were 21,123,500 ordinary shares, representing 8.86% of the total issued share capital of the Company. The shares purchased are being held as treasury shares. None of the treasury shares were cancelled or resold during current quarter and financial period ended 30 June 2017.

On 22 January 2015, the Company undertook a bonus issue of up to 115,478,803 free warrants on the basis of one warrant for every two existing ordinary shares in the Company.

During the financial period to-date, there were no warrants exercised by registered warrant holders to new ordinary shares.

As at 30 June 2017, the total warrants outstanding were 113,725,203.

B1 OPERATING SEGMENTS REVIEW

Operating Environment

The second quarter of 2017 begins with considerable political risk in the world. Elections in Europe, conflict in the Middle East, tensions on the Korean peninsula, and uncertainty about trade policy in the United States have led to a high degree of financial market volatility. The economic situation in the Eurozone looks paradoxical. Quite a few political risks continue to threaten Europe's political and economic stability. On the other hand, financial markets seem unaffected by these risks, and the recovery in the Eurozone continues. Japan's economy appears to be doing better in Q2 2017. Exports, in particular, are playing a role in reviving growth, especially given the suppressed value of the yen. Yet, domestic demand continues to be weak. Moreover, Japanese having invested heavily in the United Kingdom as a gateway to Europe, are worried that Brexit now poses a sizable risk to that investment. In Malaysia, a slowdown in export growth, a weak ringgit, and rising interest rates in the United States, along with fiscal consolidation putting a brake on government consumption, are likely to persist over the medium term. As a result, growth prospects for Malaysia in 2017 remain subdued. (Source: Deloitte University Press). The Group continues to operate under challenging market conditions in its local and export markets compared with the previous financial year.

Quarter Ended 30 June 2017 ("Q2 2017") vs Quarter Ended 30 June 2016 ("Q2 2016")

The Group's revenue and Profit Before Taxation ("PBT") were approximately RM10.12 million and RM0.54 million respectively for Q2 2017. Revenue in Q2 2017 decreased by RM0.43 million or 4.1% compared with the revenue in Q2 2016, mainly due to decrease in sales of cookware and clad metals. However, the Group's gross profit ("GP") margin for Q2 2017 increased slightly to 28.1%, compared with GP margin of 27.3% achieved in Q2 2016. Other operating income has increased by RM0.77 million to RM0.84 million in Q2 2017 mainly due to gain on disposal of quoted investments by the Company of RM0.61 million and gain on disposal of available-for-sale financial asset of RM0.09 million. Operating expenses in Q2 2017 decreased by RM4.73 million compared with Q2 2016 mainly due to recognition of the Employees' Share Option Scheme ("ESOS") fair value of RM5.03 mil in Q2 2016. The Group recorded a PBT of RM0.54 million in Q2 2017 compared with a Loss Before Tax ("LBT") of RM4.93 million in Q2 2016. Consequently, the Group achieved a Profit After Taxation ("PAT") of RM0.43 million for Q2 2017 compared with a Loss After Tax ("LAT") of RM5.02 million for Q2 2016.

6 Months Period Ended 30 June 2017 ("6M2017") vs 6 Months Period Ended 30 June 2016 ("6M2016")

The Group's performance by each Division for the financial period is as follows:

(i) Cookware Division

The Cookware Division's revenue for 6M2017 decreased by RM0.44 million or 4.2% to RM9.83 million compared with the revenue achieved in 6M2016 of RM10.27 million, as sales to the Group's key export markets declined during the 6M2017. The Group experienced lower sales of premium cookware to Japan which is the Group's major export market. However, sales to the Asia Pacific countries (excluding Japan), USA and Canada improved in 6M2017. The cookware revenue by geographical market for 6M2017 is as follows:

(ii) Convex Mirror Division

The Convex Mirror Division achieved a revenue of RM6.47 million for 6M2017, an increase of RM1.16 million compared with the revenue of RM5.31 million achieved in 6M2016. The increase in revenue is attributable to higher export sales to Japan, local markets, Europe and Korea.

(iii) Clad Metal Division

Clad Metal Division's revenue decreased in 6M2017 by RM0.26 million to RM4.23 million compared with the revenue achieved in 6M2016 of RM4.49 million. Sales of clad metal reduced in 6M2017 mainly due to decreased orders from customers in Japan, USA & Canada, Indonesia and Europe but was partially offset by increased orders from customers in Thailand and local markets.

B1 OPERATING SEGMENTS REVIEW (CONT.)

6 Months Period Ended 30 June 2017 ("6M2017") vs 6 Months Period Ended 30 June 2016 ("6M2016") (Cont.)

The Group's revenue and Profit Before Taxation ("PBT") were approximately RM20.53 million and RM0.71 million respectively for 6M2017. Revenue in 6M2017 increased by RM0.46 million or 2.3% compared with the revenue in 6M2016, mainly due to increase in sales of convex mirrors. The Group's gross profit ("GP") margin for 6M2017 increased slightly to 28.7%, compared with GP margin of 28.1% achieved in 6M2016. Other operating income in 6M2017 increased by RM0.77 million compared with 6M2016 mainly due to gain on disposal of quoted investments by the Company of RM0.61 million and gain on disposal of available-for-sale financial asset of RM0.09 million. Operating expenses in 6M2017 decreased by RM4.51 million compared with 6M2016 mainly due to recognition of the Employees' Share Option Scheme ("ESOS") fair value of RM5.03 million in 6M2016. The Group recorded a PBT of RM0.71 million in 6M2017 compared with a LBT of RM4.83 million in 6M2016. Consequently, the Group achieved a PAT of RM0.49 million for 6M2017 compared with a LAT of RM4.97 million for 6M2016.

The Group's net assets per share as at 30 June 2017 remained consistent at RM0.34. The Group's non-current assets increased to RM56.44 million compared with the non-current assets of RM55.71 million as at 31 December 2016 due to net acquisition of quoted investments of RM2.10 million but was offset by depreciation charges and disposals of plant and equipment of the Group. Inventories increased to RM18.71 million as at 30 June 2017. Receivables, deposits and prepayments decreased by RM0.47 million to RM5.10 million mainly due to collections from customers. The Group's net current assets was RM22.12 million as at 30 June 2017. The Group is in a positive net cash position as at 30 June 2017 with cash and cash equivalent of RM3.77 million after deducting all borrowings of the Group.

The Group's net operating cash inflow for 6M2017 was RM1.36 million. The net cash outflow from investing activities was RM1.28 million, mainly due to acquisition of quoted investments and purchases of plant and equipment which was partially offset by the proceeds from disposal of quoted investments and proceeds from disposal of available-for-sale financial assets. Net cash inflow from financing activities was RM1.37 million, mainly attributable to proceeds from banker acceptances. The net resultant impact to the Group's cash flow was increase in cash of RM1.42 million during 6M2017. Net cash and cash equivalents amounted to RM5.25 million as at 30 June 2017.

The Group experienced slightly lower revenue in Q2 2017 compared with Q1 2017. Consequently, the Group recorded lower GP in Q2 2017. However, the Group recorded a higher PBT and profit for the period in Q2 2017 due to gain on disposal of quoted investments by the Company of RM0.61 million and gain on disposal of available-for-sale financial asset of RM0.09 million.

B3 COMMENTARY ON PROSPECT

Despite the challenging economic and business environment, the Directors are confident of the quality and innovative capabilities of the Group to meet the product and service requirements of the customers. Intensive efforts are being made to further develop and expand existing markets as well as to penetrate into new markets worldwide and the Directors expect the business prospects for 2017 and beyond to be positive.
