NuEnergy Gas Limited (ASX: NGY) ("**NuEnergy**") advises that its Renounceable Pro-Rata Entitlement Offer of eight (8) fully paid new share for every twenty-nine (29) fully paid ordinary shares in NGY held by shareholders at the Record Date of 30 August 2024 ("**Entitlement Offer**") at an issue price of \$0.02, closed on 12 September 2024.

NuEnergy received acceptances for 299,749,949 new shares, raising a total of \$5,994,998.98.
