### **NOTICE OF 2024 ANNUAL GENERAL MEETING**

Notice is given that the Annual General Meeting of Shareholders of NuEnergy Gas Limited for 2024 will be held at the KPMG offices, Level 38, Tower Three, International Towers, 300 Barangaroo Avenue, Sydney NSW 2000 at 4pm (Sydney Time) on Tuesday, 19 November 2024. The Explanatory Statement to this Notice of Meeting provides additional information on matters to be considered at the Annual General Meeting. The Explanatory Statement and the Proxy Form are part of this Notice of Meeting.

Pursuant to Regulation 7.11.37 of the Corporations Regulations 2001 (Cth), the persons eligible to vote at the Annual General Meeting are those who are registered Shareholders of the Company at 7.00pm (Sydney Time) on 15 November 2024.

The terms and abbreviations used in this Notice and Explanatory Statement are defined in the attached Glossary.

#### **Consideration of Financial Reports of the Directors and Auditors**

To receive and consider the Financial Report together with the Directors' Report and the Auditor's Report for the Company and its controlled entities for the year ended 30 June 2024.

Shareholders will be given reasonable opportunity to ask questions about or make comments on the management of the Company.

#### Resolution 1 - Adoption of Remuneration Report

To consider, and if thought fit, to pass the following Resolution as a non-binding resolution:

"To adopt the Remuneration Report as contained in the Company's Annual Financial Report for the financial year ended 30 June 2024."

In accordance with section 250R(3) of the Corporations Act 2001 ("Corporations Act"), the vote on Resolution 1 will be advisory only. However, if more than 25% of the votes cast on this resolution are against the resolution, then the Board Spill Resolution set out in Resolution 5 will be put to Shareholders for their consideration and vote.

#### Resolution 2 - Retirement by Rotation and Re-Election of Director - Kee Yong Wah

To consider and, if thought fit, to pass the following Resolution as an ordinary resolution:

"Pursuant to Article 6.3(c) and Article 6.3(f) of the Company's Constitution and Listing Rule 14.4 and for all other purposes, Kee Yong Wah is re-elected as a Director of the Company."

#### Resolution 3 - Retirement by Rotation and Re-Election of Director - Chen Heng Mun

To consider and, if thought fit, to pass the following Resolution as an ordinary resolution:

"Pursuant to Article 6.3(c) and Article 6.3(f) of the Company's Constitution and Listing Rule 14.4 and for all other purposes, Chen Heng Mun is re-elected as a Director of the Company."

#### Resolution 4 - Approval of Issue of Equity Securities for the Purpose of ASX Listing Rule 7.1A

To consider, and if thought fit, to pass the following Resolution as a special resolution:

"That for the purposes of Listing Rule 7.1A and for all other purposes, the issue of Equity Securities up to 10% of the issued capital of the Company (at the time of the issue) calculated in accordance with the prescribed formula in Listing Rule 7.1A.2, be approved on the terms set out in the Explanatory Statement."

#### Resolution 5 - Board Spill Meeting Resolution (if required)

If less than 25% of the votes cast on Resolution 1 are voted against the adoption of the Remuneration Report, the Chairman will withdraw Resolution 5.

To consider and, if thought fit, to pass the following resolution as an **ordinary resolution**:

"That for the purposes of section 250V(1) of the Corporations Act and for all other purposes:

- (i) an extraordinary meeting of Shareholders (the "Spill Meeting") be held within 90 days of the passing of this resolution;
- (ii) all the Company's Directors who were in office when the Directors' Resolution to have the Directors' Remuneration Report for the year ended 30 June 2024 considered at the Annual General Meeting was passed and who remain in office at the time of the Spill Meeting, cease to hold office immediately before the end of the Spill Meeting; and
- (iii) resolutions to appoint persons to offices that will be vacated immediately before the end of the Spill Meeting be put to the vote of Shareholders at the Spill Meeting."

#### **Voting Exclusions**

Voting exclusions apply to Resolutions 1, 4 and 5 (if required) as set out below.

#### Resolutions 1 and 5

The Company will disregard any votes cast on Resolutions 1 and 5 (if required):

- by or on behalf of a member of the KMP whose remuneration details are included in the Remuneration Report for the year ended 30 June 2024 (or a Closely Related Party of that member of the KMP), regardless of the capacity in which the vote is cast; or
- as proxy by a person who is a member of the KMP as at the date of the Meeting or a Closely Related Party of a member of the KMP,

unless the vote is cast as proxy for a person entitled to vote on Resolutions 1 and 5 (if required), either:

- in accordance with directions given to the proxy when completing the online proxy appointment process referred to above; or
- by the Chairman in accordance with an express authorisation provided through the online proxy appointment process to vote as the proxy decides, even if Resolutions 1 and 5 are connected directly or indirectly with the remuneration of a member of the KMP.

#### Resolution 4

The Company will disregard any votes cast on Resolution 4:

• if at the date of the Meeting, the Company is proposing to make an issue of equity securities under Listing Rule 7.1A2, any person (and any Associates of such person) who is expected to participate in or who will obtain a material benefit as a result of, the proposed issue under the 10% Placement Capacity (except a benefit solely by reason of being a holder of ordinary securities in the Company).

However, this does not apply to a vote cast in favour of Resolution 4 by:

- a person as proxy or attorney for a person who is entitled to vote on Resolution 4, in accordance with directions given to the proxy or attorney to vote on Resolution 4 in that way; or
- the Chair of the Meeting as proxy or attorney for a person who is entitled to vote on Resolution 4, in accordance with a direction given to the Chair to vote on Resolution 4 as the Chair decides; or
- a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
  - o the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an Associate of a person excluded from voting, on Resolution 4; and
  - the holder votes on Resolution 4 in accordance with directions given by the beneficiary to the holder to vote in that way.

However, the Company need not disregard a vote in relation to Resolutions 1, 4 and 5 if it is cast by:

- 1. a person as proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form; or
- 2. the person chairing the meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

The Company is not required to disregard any votes cast, including by a member of the KMP (including each of the directors and executives named in the Company's Remuneration Report) or that KMP's closely related party on the resolutions to re-elect Directors at the Spill Meeting

#### **Voting by Proxy**

The *Corporations Act* places certain restrictions on the ability of KMP and their Closely Related Parties to vote on resolutions connected directly or indirectly with the remuneration of the Company's KMP.

For those reasons, Shareholders who intend to vote by proxy should carefully consider the identity of their proxy and consider appointing someone other than one of the Company's KMP as such proxies may not be able to vote undirected proxies.

If you appoint the Chairman as your proxy by marking the box in **STEP 1** on the Proxy Form then you are providing express authorisation for the Chairman to vote on all Resolutions in accordance with his intentions as set out in this Notice and the Proxy Form (except where you have indicated a different voting intention by marking the voting boxes in **STEP 2** on the Proxy Form).

This express authorisation acknowledges that the Chairman may exercise your proxy in relation to Resolution 1 even though it is connected with remuneration of a member of KMP is a Resolution in respect of which the Chairman of the meeting has an interest.

The Chairman intends to vote available proxies **in favour** of Resolutions 1, 2, 3 and 4 and **against** Resolution 5 (if a vote is required for Resolution 5).

#### **EXPLANATORY STATEMENT**

This Explanatory Statement has been prepared for the information of the Shareholders of the Company in connection with the business to be conducted at the Annual General Meeting to be held at the KPMG offices, Level 38, Tower Three, International Towers, 300 Barangaroo Avenue, Sydney, NSW 2000 at 4pm (Sydney Time) on Tuesday, 19 November 2024.

The purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting.

#### **Financial Statements and Reports**

The *Corporations Act* requires the Company to place its Financial Report, Directors' Report and Auditor's Report for the last financial year before the Annual General Meeting. No resolution is required for this Item, but Shareholders will be given a reasonable opportunity to ask questions and to make comments on the reports and the management and performance of the Company.

The Company's Auditor will also be present at the meeting and Shareholders will be given the opportunity to ask the Auditor questions about the conduct of the audit, the preparation and content of the Auditor's Report, the accounting policies adopted by the Company and the independence of the Auditor.

The Company's 2024 Annual Report is available on the Company's website at www.nuenergygas.com.

#### Resolution 1 - Adoption of Remuneration Report

The Remuneration Report sets out the Company's remuneration arrangements for the Directors and senior management of the Company (**Key Management Personnel**). The Remuneration Report is part of the Directors' Report contained in the Annual Report of the Company for the financial year ended 30 June 2024.

In accordance with section 250R(3) of the Corporations Act, the vote of Resolution 1 is advisory only and does not bind the Directors or the Company. However, at the Company's 2023 Annual General Meeting more than 25% of the votes were cast against the adoption of the 2023 Remuneration Report. Pursuant to section 250V of the Corporations Act, if at the 2024 Annual General Meeting 25% or more of votes cast are against the adoption of the Remuneration Report, Shareholders are required to vote on Resolution 5 ("Spill Resolution") on whether a further general meeting of the Company ("Spill Meeting") will be convened at which all of the Company's Directors must stand for re-election should they wish to continue as Directors.

If more than 50% of votes cast are in favour the Spill Resolution, the Company must convene a Spill Meeting within 90 days after the Spill Resolution was passed.

If the Spill Resolution is passed, all of the Directors of the Company who were in office when the Directors' Report was approved will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as Directors of the Company is approved will be the Directors of the Company.

As set out in the Explanatory Statement in relation to Resolution 5 below, if at the 2024 Annual General Meeting 25% or more of votes cast are against Resolution 1, Shareholders will be required to vote on Resolution 5.

## Why should Shareholders vote in favour of the Remuneration Report?

The Board has noted and considered the no vote received against the 2023 Remuneration Report. The Board wishes to highlight that as mentioned in the 2024 Remuneration Report, since 2019, as part of the Directors' efforts to commit to the sustainability of the Group ("Directors' Commitment"), the Directors will amongst others waive entirely their right to fees and salaries with effect from 1 January 2020 until new and sufficient funding is received by the Company.

# **Directors' Recommendation**

The Directors recommend that Shareholders vote in favour of the adoption of the Remuneration Report.

#### Resolution 2 – Re-Election of Director – Kee Yong Wah

Pursuant to Article 6.3(c) of the Company's Constitution and the Listing Rule 14.4, one-third of the Directors of the Company (rounded down to the nearest whole number) must retire each year. Pursuant to Article 6.3(f) of the Company's Constitution, a retiring Director may then be eligible for re-election. Kee Yong Wah retires by rotation pursuant to these requirements and is eligible for re-election.

Resolution 2 seeks Shareholder approval for the re-election of Kee Yong Wah as a Director of the Company.

Details of Mr Kee's qualifications and experience are contained in the Company's 2024 Annual Report.

#### **Directors' Recommendation**

The Directors (other than Mr Kee who abstains given his personal interest in the Resolution) recommend that Shareholders vote **in favour** of the re-election of Mr Kee.

#### Resolution 3 - Re-Election of Director - Chen Heng Mun

Pursuant to Article 6.3(c) of the Company's Constitution and the Listing Rule 14.4, one-third of the Directors of the Company (rounded down to the nearest whole number) must retire each year. Pursuant to Article 6.3(f) of the Company's Constitution, a retiring Director may then be eligible for re-election. Chen Heng Mun retires by rotation pursuant to these requirements and is eligible for re-election.

Resolution 3 seeks Shareholder approval for the re-election of Mr Chen as a Director of the Company.

Details of Mr Chen's qualifications and experience are contained in the Company's 2024 Annual Report.

#### **Directors' Recommendation**

The Directors (other than Mr Chen who abstains given his personal interest in the Resolution) recommend that Shareholders vote **in favour** of the re-election of Mr Chen.

#### Resolution 4 – Approval of issue of Equity Securities for the purpose of ASX Listing Rule 7.1A

#### Overview

ASX Listing Rule 7.1A provides that an Eligible Entity (as defined below) may seek shareholder approval by special resolution passed at an annual general meeting to have the capacity to issue up to that number of Equity Securities (as defined below) equal to 10% of its issued capital as calculated in accordance with the formula in ASX Listing Rule 7.1A.2 (10% Placement Capacity) without using that entity's existing 15% annual placement capacity under ASX Listing Rule 7.1.

An **Eligible Entity** is one that, as at the date of the relevant annual general meeting:

- a) is not included in the S&P/ASX 300 Index; and
- b) has a maximum market capitalisation of \$300,000,000.

As at the date of this Notice, the Company is an Eligible Entity as it is not included in the S&P/ASX 300 Index and has a current market capitalisation of \$37,394,814 (based on the number of Shares on issue and the closing price of Shares on ASX on 27 September 2024). However, the Company will only be permitted to seek approval for the 10% Placement Capacity if it remains an Eligible Entity at the date of the Meeting. Accordingly, if the Company is not an Eligible Entity at the date of the Meeting, Resolution 4 will not be put to, and voted on at, the Meeting.

An **Equity Security** is a share, a unit in a trust, a right to a share or unit in a trust or Option, an option over an issued or unissued security, a convertible security, or, any security that ASX decides to classify as an equity security, but not a security ASX decides to classify as a debt security.

Any Equity Securities issued under the 10% Placement Capacity must be in the same class as an existing class of quoted Equity Securities. As at the date of this Notice, the Company currently has one class of quoted Equity Securities on issue, being the Shares (ASX Code: NGY).

Subject to the Company being an Eligible Entity and Resolution 4 being put to the Meeting, if Shareholders approve Resolution 4, the number of Equity Securities the Company may issue under the 10% Placement Capacity will be determined in accordance with the formula prescribed in ASX Listing Rule 7.1A.2.

If Resolution 4 is passed, the Company will be able to issue equity securities up to the combined 25% limit in ASX Listing Rules 7.1 and 7.1A without any further shareholder approval.

If Resolution 4 is not passed, the Company will not be able to access the additional 10% Placement Capacity to issue equity securities without shareholder approval provided for in ASX Listing Rule 7.1A and will remain subject to the 15% limit on issuing equity securities without shareholder approval set out in ASX Listing Rule 7.1.

Resolution 4 is a special resolution. Accordingly, at least 75% of votes cast by Shareholders present (in person, or by proxy or representative) and eligible to vote at the Meeting must be in favour of Resolution 4 for it to be passed.

#### Technical information required by ASX Listing Rule 7.3A

Pursuant to and in accordance with ASX Listing Rule 7.3A, the information below is provided in relation to this Resolution 4:

#### (a) Period for which mandate is valid

An approval under ASX Listing Rule 7.1A commences on the date of the annual general meeting at which the approval is obtained and expires on the first to occur of the following:

- the date that is 12 months after the date of the annual general meeting at which the approval is obtained;
- ii) the time and date of the entity's next annual general meeting; and
- the time and date of the approval by holders of the Eligible Entity's ordinary securities of a transaction under Listing Rule 11.1.2 or Listing Rule 11.2.

#### (b) Minimum price

The minimum price at which the Equity Securities may be issued is 75% of the volume-weighted average market price of Equity Securities in that class, calculated over the 15 ASX trading days on which trades in that class were recorded immediately before:

- i) the date on which the price at which the Equity Securities are to be issued is agreed by the Company and the recipient of the Equity Securities; or
- ii) if the Equity Securities are not issued within 10 ASX trading days of the date in paragraph (i), the date on which the Equity Securities are issued.

#### (c) Purpose of issue under 10% Placement Capacity

The Company may seek to issue the Equity Securities under the 10% Placement Capacity for the following purposes:

• cash consideration to complete its remaining exploration commitments and further move its gas assets to development and commercialisation stage.

The Company will comply with the disclosure obligations under Listing Rules 7.1A.4 and 2.7 upon issue of any Equity Securities.

#### (d) Risk of voting dilution

Any issue of Equity Securities under the 10% Placement Capacity will dilute the interests of Shareholders who do not receive any Shares under the issue.

The table below shows the potential dilution of Shareholders calculated in accordance with the formula in ASX Listing Rule 7.1A.2 (assuming Resolution 4 is passed by Shareholders), on the basis of the market price of Shares and the number of Shares on issue as at 27 September 2024.

The table assumes differing numbers of Shares on issue (ie variable "A" in the above formula) and issue prices for Shares over three scenarios, but in each scenario it is assumed that the Company issues the maximum number of Shares available under the 10% Placement Capacity. For example:

- Variable 'A' differs across each scenario. Scenario 1 assumes there is no change to the number of Shares on issue. Scenarios 2 and 3 then assume an increase of 50% and 100% (respectively) to the number of Shares on issue.
- Within each scenario, three different issue prices for the Shares are assumed. One of the issue prices is
  the closing price on 27 September 2024 (being the last practicable trading day prior to the date of this
  Notice). The other two issue prices then assume a 50% decrease to that closing Share price and a 100%
  increase to that price.

Note: The number of Shares on issue (Variable 'A' in the formula) could increase as a result of the issue of Shares that do not require Shareholder approval (such as under a pro- rata rights issue or scrip issued under a takeover offer) or that are issued with Shareholder approval under ASX Listing Rule 7.1.

#### The table above uses the following assumptions:

- 1. The number of Shares on issue is 1,780,705,446, which was the number of Shares the Company had on issue as at 27 September 2024.
- 2. The issue price set out above is the closing price of the Shares on the ASX on 27 September 2024.
- 3. The Company issues the maximum possible number of Equity Securities under the 10% Placement Capacity.
- 4. The Company has not issued any Equity Securities in the 12 months prior to the Meeting that were not issued under an exception in ASX Listing Rule 7.2 or with approval under ASX Listing Rule 7.1.
- The issue of Equity Securities under the 10% Placement Capacity consists only of Shares. It is assumed that no Options are exercised into Shares before the date of issue of the Equity Securities.
- 6. The calculations above do not show the dilution that any one particular Shareholder will be subject to. All Shareholders should consider the dilution caused to their own shareholding depending on their specific circumstances.
- 7. This table does not set out any dilution pursuant to approvals under ASX Listing Rule 7.1.
- 8. The 10% voting dilution reflects the aggregate percentage dilution against the issued share capital at the time of issue. This is why the voting dilution is shown in each example as 10%.
- 9. The table does not show an example of dilution that may be caused to a particular Shareholder by reason of placements under the 10% Placement Capacity, based on that Shareholder's holding at the date of the Meeting

Shareholders should note that there is a risk that:

- (i) the market price for the Company's Shares may be significantly lower on the issue date than on the date of the Meeting; and
- (ii) the Shares may be issued at a price that is at a discount to the market price for those Shares on the date of issue, which may have an effect on the amount of funds raised by the issue of the Shares.

#### (e) Allocation policy under the 10% Placement Capacity

The identity of the recipients of the Equity Securities to be issued under the 10% Placement Capacity will be determined on a case-by-case basis at the time of issue and in the Company's discretion. However, the recipients of Equity Securities could consist of current Shareholders or new investors (or both), none of whom will be related parties of the Company.

The Company will determine the recipients at the time of the issue under the 10% Placement Capacity, having regard to the following factors:

- i) the purpose of the issue;
- ii) alternative methods for raising funds available to the Company at that time, including, but not limited to, an entitlement issue or other offer where existing Shareholders may participate;
- iii) the effect of the issue of the Equity Securities on the control of the Company;
- iv) the circumstances of the Company, including, but not limited to, the financial position and solvency of the Company;
- v) prevailing market conditions; and
- vi) advice from corporate, financial and broking advisers (if applicable).

#### (f) Previous approval under ASX Listing Rule 7.1A

The Company previously obtained approval from its Shareholders pursuant to ASX Listing Rule 7.1A at its annual general meeting held at 12 noon on 23 November 2023 (**Previous Approval**).

As at the date of this Notice, the Company has not issued any Equity Securities pursuant to the Previous Approval.

For the purposes of ASX Listing Rule 7.3A.6(a), the Company notes that, as at the date of this Notice, the Company has not issued or agreed to issue any Equity Securities during the following period preceding the date of the Meeting, being on and from 21 November 2023 to 18 November 2024.

#### (g) Compliance with ASX Listing Rule 7.1A.4

When the Company issues Equity Securities pursuant to the 10% Placement Capacity, it must:

- state in its announcement of the proposed issue under Listing Rule 3.10.3 or in its application for quotation of the securities under Listing Rule 2.7 that the securities are being issued under Listing Rule 7.1A; and
- give to ASX immediately after the issue a list of names of the persons to whom the Company issued the
  equity securities and the number of equity securities issued to each. This list is not for release to the
  market.

A voting exclusion statement is set out on page 4 of this Notice.

The Directors unanimously recommend that Shareholders VOTE IN FAVOUR of Resolution 4.

#### Resolution 5 - Board Spill Resolution

Resolution 5 is the Spill Resolution. Please refer to the Explanatory Statement for Resolution 1 for further information on the Spill Resolution.

If less than 25% of the votes cast on Resolution 1 are voted against the adoption of the Remuneration Report, the Spill Resolution is not required and the Chairman will withdraw Resolution 5.

#### **Spill Meeting**

If the Spill Resolution (which is an ordinary resolution) is passed the Company must hold the Spill Meeting within 90 days after the Spill Resolution was passed.

Section 250V of the Corporations Act, which sets out the statutory requirements of a Spill Meeting resolution, applies to all of the Directors in office when the Board resolution to approve the Directors' Report was passed. Consequently,

if a Spill Meeting is held, the following Directors will cease to hold office immediately before the end of the Spill Meeting unless they are willing to stand for re-election and are re-elected at that meeting:

- Mr Kong Kok Leong
- Mr Chen Heng Mun
- Mr Alan Fraser
- Mr Ian Wang
- Mr Kee Yong Wah
- Mr Goh Tian Chuan

Even if Mr Kee and Mr Chen are re-elected at this year's Annual General Meeting pursuant to Resolutions 2 and 3, Mr Kee and Mr Chen will still need to be re-elected at the Spill Meeting to remain in office after the Spill Meeting.

The Directors appointed at the Spill Meeting will commence to hold office at the end of the Spill Meeting.

The voting exclusion statement for this resolution is set out on page 4 of this Notice of Meeting.

#### Directors' Recommendation

If Resolution 5 is put to the Meeting, the Directors unanimously recommend that Shareholders vote <u>against</u> Resolution 5 on the basis that it would be extremely disruptive to the Company and in the Board's view, it would be inappropriate to remove these Directors in the circumstances. However, the Board recognises that Shareholders can remove a director by a majority Shareholder vote at any time and for any reason.

#### Instructions for Completing 'Appointment of Proxy' Form

- A member entitled to attend and vote at an Annual General Meeting is entitled to appoint not more than two proxies to
  attend and vote on their behalf. Where more than one proxy is appointed, each proxy must be allocated a proportion of
  the member's voting rights. If the shareholder appoints two proxies and the appointment does not specify this proportion,
  each proxy may exercise half the votes.
- 2. A duly appointed proxy need not be a member of the Company. In the case of joint holders, all must sign.
- 3. Corporate shareholders should comply with the execution requirements set out on the Proxy Form or otherwise with the provisions of Section 127 of the *Corporations Act*. Section 127 of the *Corporations Act* provides that a company may execute a document without using its common seal if the document is signed by:
  - 3.1. 2 directors of the company;
  - 3.2. a director and a company secretary of the company; or
  - 3.3. for a proprietary company that has a sole director who is also the sole company secretary that director.

For the Company to rely on the assumptions set out in Section 129(5) and (6) of the *Corporations Act*, a document must appear to have been executed in accordance with Section 127(1) or (2). This effectively means that the status of the persons signing the document or witnessing the affixing of the seal must be set out and conform to the requirements of Section 127(1) or (2) as applicable. In particular, a person who signs the document or witnesses the affixing of a common seal and who is the sole director and sole company secretary of the company must state that next to his or her signature.

- 4. Completion of a Proxy Form will not prevent individual shareholders from attending the meeting in person if they wish. Where a shareholder completes and lodges a valid Proxy Form and attends the meeting in person, then the proxy's authority to speak and vote for that shareholder is suspended while the shareholder is present at the meeting
- 5. Where a Proxy Form or form of appointment of corporate representative is lodged and is executed under power of attorney, the power of attorney must be lodged in like manner as the Proxy Form.
- 6. You can direct your proxy how to vote on each Resolution by completing STEP 2 on the Proxy Form.
- 7. If you appoint the Chairman as your proxy by marking the box in **STEP 1** on the Proxy Form then you are providing express authorisation for the Chairman to vote on all Resolutions in accordance with his intentions as set out in this Notice and the Proxy From (except where you have indicated a different voting intention by marking the voting boxes in **STEP 2** on the Proxy Form).

This express authorisation acknowledges that the Chairman may exercise your proxy in relation to Resolutions 1 and 5 even though these Resolutions are connected with remuneration of a member of KMP and in which the Chairman of the meeting has an interest.

Votes cast by the Chairman on Resolutions 1 and 5 other than as authorised proxy holder will be disregarded because of his interest in the outcome of the Resolutions.

The Chairman intends to vote available proxies in favour of Resolutions 1, 2, 3 and 4 and against Resolution 5.

- 8. If you appoint a KMP other than the Chairman at **STEP 1**, and do not complete **STEP 2**, your vote will not be counted in respect of Resolutions 1 and 5.

Select the 'Voting' tab and then follow the prompts. You will be taken to have signed your Proxy Form if you lodge it in accordance with the instructions given on the website,

so that it is received not later than 4pm (Sydney Time) on 17 November 2024.

Proxy Forms received later than this time will be invalid.

#### **VOTES ON ITEMS OF BUSINESS – PROXY APPOINTMENT**

You may direct your proxy how to vote by placing a mark in one of the boxes opposite each item of business. All your shares will be voted in accordance with such a direction unless you indicate only a portion of voting rights are to be voted on any item by inserting the percentage or number of shares you wish to vote in the appropriate box or boxes. If you do not mark any of the boxes on the items of business, your proxy may vote as he or she chooses. If you mark more than one box on an item your vote on that item will be invalid.

#### APPOINTMENT OF A SECOND PROXY

To appoint a second proxy you must:

If the appointments do not specify the percentage or number of votes that each proxy may exercise, each proxy may exercise half your votes. Fractions of votes will be disregarded; and

(b) return both forms together.
